

**RELATIVE TO RECOGNIZING AND COMMENDING THE ACCOMPLISHMENTS OF DANIEL G. MOFFAT, PRESIDENT AND CHIEF EXECUTIVE OFFICER OF GTA TELEGUAM; TO EXTENDING A SINCERE *UN DANGKULO NA SI YU'OS MA'ASE'* TO MR. MOFFAT FOR HIS CONTRIBUTIONS TO EXPAND ECONOMIC GROWTH, BUSINESS AND CULTURAL INTERESTS ON THE ISLAND OF GUAM.**

1           **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I MINA'TRENTAI UNU***  
2 ***NA LIHESLATURAN GUÅHAN:***

3           **WHEREAS,** Dan Moffat came to Guam as the President and Chief Executive Officer of  
4 GTA TeleGuam in January 2007 to lead then fledgling GTA TeleGuam in providing complete  
5 communications services to island residents and businesses after its privatization from the  
6 Government of Guam; and

7           **WHEREAS,** Dan, utilizing his quarter century of experience in the telecommunications  
8 industry, led the creation of a highly competitive market environment benefiting all island residents  
9 and businesses through overall improved services, lower costs, and innovative new services for *todu*  
10 *Guåhan*; and

11           **WHEREAS,** under Dan Moffat's leadership, GTA TeleGuam has embodied the spirit of  
12 entrepreneurship by being first in providing innovative products and services such as the  
13 BlackBerry, the Apple iPhone, and digital television as a first-time competitive offering for pay  
14 television service on Guam; and

1           **WHEREAS**, under Dan’s guidance, GTA TeleGuam has recruited, trained, and developed a  
2 local management team and staff with deep knowledge and expertise in the areas of traditional  
3 telephony, broadband Internet access, wireless, digital television, and emerging technologies; and

4           **WHEREAS**, in helping build a world-class communications infrastructure for Guam and the  
5 region with local talent and resources, Dan instilled a corporate philosophy of “*Always There*” for  
6 its customers and GTA TeleGuam employees; and

7           **WHEREAS**, as part of that corporate philosophy, Dan has embraced the island community  
8 and local culture by adopting and fostering values such as *inafa’maolek, chenchule’*, and *respetu* for  
9 incorporation in business practices to actively promote the well being of the community; and

10           **WHEREAS**, in addition to introducing and providing cutting-edge services and products for  
11 Guam’s consumers, Dan has created a corporate philosophy of giving back to the community  
12 through active employee volunteerism and major corporate philanthropy with support to numerous,  
13 worthy, not-for-profit organizations that are doing excellent work for the island and its residents.  
14 Involvement in such initiatives and participation in programs and organizations such as Relay for  
15 Life, YellowBook Round Up, USO, Make A Wish, American Red Cross, Strides For A Cure, Down  
16 Syndrome Association of Guam, Guam Diabetes Association, Rainbows For All Children,  
17 University of Guam Endowment Fund and Small Business and Public Administration Advisory  
18 Council, Guam Community College Apprenticeship Program, Hurao Academy, Armed Forces  
19 Committee of the Guam Chamber of Commerce, Rotary Club of Guam, Tourism Education Council,  
20 American Cancer Society, Chinese Chamber of Commerce, Crimestoppers, Guahan Napu, Guam  
21 Cycling Federation, Guam Football Association, Guam Humanities Council, Guam Museum  
22 Foundation, Guam National Youth Football Federation, Guam Nurses Association, Guam Society of  
23 America, Guam Veterans Association, Hagatna Pool Foundation, Inafa Maolek, Kamalen Karidat,  
24 PBS, KPRG, Liberation Day Committee, Micronesian Area Research Center, Proa Group, Sagan  
25 Kotturan Chamorro, Salvation Army, Charlie Corn Scholarship Fund, Small Business Development  
26 Center, Special Olympics, and the US Navy League;

27           **RESOLVED**, that the Committee on Rules of *I Mina Trentai Unu Na Liheslaturan Guåhan*  
28 does hereby, on behalf of *I Liheslaturan Guåhan* and the People of Guam commend, recognize and  
29 does further extend a sincere *Un Dangkulo Na Si Yu’os Ma’ase’* to Dan Moffat for his invaluable  
30 contributions to the community of Guam, the vast improvements in deliverance of quality services  
31 and innovations to the telecommunications industry on island, and for his genuine leadership to  
32 develop and cultivate local talent at GTA TeleGuam; and be it further
