


3 **WHEREAS**, the Guam Surgicenter, LLC has been an important part of the
4 Guam community by providing needed services to the people of Guam through
5 urgent, emergent and elective surgery procedures; and

6 **WHEREAS**, the first meeting of the Guam Surgicenter, LLC took place on
7 August 28, 2000 and the Guam Surgicenter, LLC took on its first case on October
8 24, 2011; and

9 **WHEREAS**, the Guam Surgicenter, LLC was founded under the leadership
10 of the Board of Directors: Jan Bollinger, MD; Ronald Kobayashi, MD; Jerone
11 Landstrom, MD; Mr. William McMillan and Mr. Joe Husslein and founding
12 members: John Rosoff, MD; Farrell Cole, MD and Marlin Larsen, PhD; and

1 **WHEREAS**, the Guam Surgicenter, LLC continues its service to the
2 community of Guam today under the leadership of the current Board of Directors:

4 Kobayashi, MD; William Fell, MD; Ms. Alicia Iseke and Mr. Michael Ysrael; and

5 **WHEREAS**, the people of Guam recognize the hard work and dedication of
6 Pacific Medical Management; TakeCare Ins. Co.; Jan Bollinger, MD; Jerone
7 Landstrom, MD; Farrell Cole, MD; Jaroslav Richter, MD; Ronald Kobayashi, MD;
8 William Fell, MD; Harvard Medical Park; Mr. Michael Ysrael; Suresh Krishnan,
9 MD; Sung Park, MD; Saied Safabakhsh, MD; Mohammed Madantschi, MD;

16 attention to the people of Guam in dental, general, gynecology, ophthalmology,
17 orthopedic, otorhinolaryngology, plastic, podiatry and urology services; and

18 **WHEREAS**, in the past ten (10) years, the Guam Surgicenter has brought
19 in new Arthroscopy equipment and instrumentation for Orthopedic procedures to
20 better service their patients; and

21 **WHEREAS**, the Guam Surgicenter assisted in bringing Dr. Fitzsimmons,
22 the only Sports Medicine Orthopedic Surgeon to the island. Dr. Fitzsimmons is
23 performing the latest surgical interventions for shoulders and knees with an
24 emphasis on Sports Medicine, performing procedures such as Rotator Cuff Repairs
25 and Anterior Cruciate Ligament Repairs; and

26 **WHEREAS**, they also brought Dr. Fell, the only
27 Otorhinolaryngologist (ENT) to the island; and
