WHEREAS, despite relocating to Guam, she maintain her pride in her Filipino culture by making contributions to the local Filipino community, both as an individual and as a member of the Iloilo Association of Guam and as former secretary of the Panaynon Association of Guam; and

WHEREAS, when Florita's virtues were spoken of, her children noted "What is most admired of our mom is her strong faith in God, and her love for Jesus and Mother Mary!"; and

WHEREAS, due to her values in both education and her faith that she served as a former CCD teacher at Our Lady of Guadalupe Church in Santa Rita and also helped form and was former president for the Legion of Mary for the Santa Rita parish.
