Between July 1989 and December 1991, Mr. 5 Lizama served as a Test Development and Validation Specialist III and later served as a 6 Personnel Specialist IV from December 1991 to September 1998 in the same division. He 7 then transferred to the Civil Service Commission where he was employed as a Personnel 8 Management Analyst III from October 1998 to December 2005; and 9 WHEREAS, in December 2005, Mr. Raymond T. Lizama returned to the Department 10 of Administration's Personnel Services Division as a Personnel Management Analyst III. 11 He later served as the Personnel Services Administrator for the Department of Education 12 from November 2006 to December 2007. Following his brief tenure at the Department of 13 Education, Mr. Lizama assumed responsibilities of his former position as a Personnel 14 Management Analyst III at the Civil Service Commission from December 2007 to 15 September 2009; and 16 WHEREAS, Mr. Raymond T.
