3 **WHEREAS**, the Bolinao-Bani Association of Guam was organized in 1989
4 and made possible by the efforts of Gil Caasi, Tommy Cabanayan, †Elias
5 Calicdan, Van Carranza, Pastor Celeste, Lenor Fernandez, Virgilio Leones,
6 Rolando Odero, †Diosdado Caasi, †Amor Capucao Sr. and their families in the
7 spirit of brotherhood, unity, social acquaintance and mutual aid among Bolinao and
8 Bani residents of Guam; and

9 **WHEREAS**, Bolinao-Bani Association of Guam is a non-profit civic
10 organization whose main objective is for the general membership to contribute to
11 the economic growth of the towns of Bolinao and Bani, Pangasinan Philippines
12 and the island of Guam by helping local charitable institutions such as American
13 Red Cross, American Cancer Society, Catholic Social Services and community
14 projects; and

1 **WHEREAS**, the association has been able to foster goodwill and friendship
2 among its members while accomplishing their various goals through members'
3 interest and participation. The sacrifices, hard work, support and cooperation from
4 each member of the Bolinao-Bani Association of Guam has greatly contributed to
5 the success of all the association's activities; and

6 **WHEREAS**, BBAG has also made generous contributions to Salvation
7 Army, Guam Lytico & Bodig, Sugar Plum Tree, People Helping People, South
8 Pacific Games, St. Dominic's Senior Care Home, Pangasinan Community of Guam
