3 WHEREAS, Alan Sanchez San Nicolas is the proud son of the late Albert and the

4 late Joaquina San Nicolas from the village of Malessso, and is married to Sergeant Ann

5 San Nicolas. Sergeants Alan and Ann San Nicolas are the proud parents of Alan

6 Michael and Alex David San Nicolas; and

7 WHEREAS, Alan graduated from Inarajan High School and began his career at

8 the Department of Corrections at the age of nineteen (19) in May 1985 working in every

9 post of the Department of Corrections (DOC), specifically assigned to the Maximum

10 Security Unit and General Population; and

33 **WHEREAS**, On February 22, 2006, Corporal San Nicolas was promoted to the
34 rank of Sergeant and was reassigned to the Third Platoon as Assistant Commander and

36 Community Corrections Center as a Unit Manager after the relocation of the center back
37 to the Mangilao Facility. A few years later, Sergeant San Nicolas was reassigned to the
38 Special Housing Unit; and

39 **WHEREAS**, In 2010, Sergeant San Nicolas was transferred to the *Hagatna*
40 Detention Facility and assigned as the Commander then shortly thereafter, was
41 returned to the main facility and assigned to the First Platoon as the Commander; and

42 **WHEREAS**, In June 29, 2012, Sergeant San Nicolas officially retired from the
43 government of Guam with a final promotion to the rank of Lieutenant; now, therefore
44 be it
