Relative to urging members of the Guam Chamber of adopt, Commerce to within their business establishments, "better customer service policies" as provided in P.L. 30-171 for government agencies, and other measures of I Liheslaturan Guåhan, Man'amko' and individuals with disabilities and special needs, including mental illness.

RESOLVED BY THE COMMITTEE ON RULES OF I 1

MINA'TRENTAI UNU NA LIHESLATURAN GUÅHAN: 2

- WHEREAS, I Liheslaturan Guåhan finds that as of 2010, the U.S. 3
- Census Bureau recorded Guam's population at approximately one 4
- hundred fifty-nine thousand, three hundred fifty-eight (159,358). 5
- Moreover, according to the Department of Integrated Services for 6
- Individuals with Disabilities, there are approximately fifteen thousand 7
- (15,000) individuals currently on Guam with a disability or special need, 8

including mental illness. The Department of Public Health and Social Services' Division of Senior Citizens estimates that there are nearly twenty thousand (20,000) individuals currently on Guam who are age sixty (60) and over. Senior Citizens are warmly referred to in Guam's native language as *Man'amko'*; and

WHEREAS, Guam's Man'amko' and individuals with disabilities and special needs, including mental illness, confront health, emotional, financial and other life challenges at a level much different than younger individuals as well those without disabilities or special needs; and

WHEREAS, many of Guam's *Man'amko'* and individuals with disabilities and special needs, including mental illness, rely on some form of public assistance from the federal government and government of Guam, including full or supplemental support comprising of at least one (1) or a combination of the following: food, housing, healthcare and transportation; and

WHEREAS, Guam's *Man'amko'* and individuals with disabilities and special needs, including mental illness, receive additional support by way

of in-kind and service donations, education and awareness activities and volunteer work their families, business establishments and private citizens extend; and

WHEREAS, in an effort to improve government services for the *Man'amko'* and individuals with disabilities and special needs, including mental illness, *I Liheslaturan Guåhan* passed Bill No. 379-30 (LS) in July 2010 which became P.L. 30-171; and

whereas, P.L. 30-171 requires all agencies, public corporations and instrumentalities of the government of Guam to ensure that the *Man'amko'* and individuals with mobility disabilities are allowed to move to the front of the line for customer service requests and remittance of payments; and whereas, prior to the enactment of P.L. 30-171, *I Liheslaturan Guåhan* passed Bill No. 293-31 (COR) in March 2010, which became P.L. 30-99. This law also sought to improve services for individuals with disabilities, by requiring the Department of Revenue and Taxation to issue license plates or decalcomania (one [1] or the other) and/or placards to

individuals with speech and/or hearing disabilities. Among the benefits of

this legislation, emergency services personnel are now able to easily recognize and appropriately respond to traffic emergencies involving individuals with disabilities; and

WHEREAS, in February 2012, *I Liheslaturan Guåhan* passed Bill No. 296-31 (LS), which became P.L. 31-172. This legislation requires individuals applying to serve as a corrections officer to establish satisfactory evidence of the ability to understand and work with persons with disabilities, including special needs and mental illness; and

WHEREAS, a separate measure, Bill No. 417-31 (COR), was also introduced in early 2012. If enacted, this proposal would require police officers, firefighters and other public safety and law enforcement officers within the government of Guam to receive training, as coordinated by the Department of Integrated Services for Individuals with Disabilities, relative to recognizing and handling situations involving persons with disabilities, including mental illness; and

WHEREAS, it is the intent of *I Liheslaturan Guåhan*, through these separate measures, to improve upon the delivery of public services to the

WHEREAS, I Liheslaturan Guåhan further intends, through this legislative resolution, to urge members of the Guam Chamber of Commerce to implement "better customer service" practices allowing the Man'åmko and individuals with disabilities and special needs, including mental illness, to make payments, seek assistance, or otherwise communicate with little to no difficulty with employees engaged in providing customer service; and, therefore be it

RESOLVED, that I Mina' Trentai Unu na Liheslaturan Guåhan does 69 hereby, on behalf of the people of Guam, urges members of the Guam 70 Chamber of Commerce to adopt, within their business establishments, 71 "better customer service policies" as provided in P.L. 30-171 for government 72 agencies, and other measures of I Liheslaturan Guåhan, for the Man'amko 73 and individuals with disabilities and special needs, including mental 74 therefore illness; be it 75 now,
