**Relative to recognizing Jeju Air on their Inaugural flight from Incheon-Seoul to Guam and commending Jeju Air for this expansion and the opportunity for Guam to welcome additional visitors from Korea, diversifying and strengthening our tourism industry and benefitting our island's economy; and to further**

1           **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**  
2 ***MINA'TRENTAI UNU NA LIHESLATURAN GUÅHAN:***

3           **WHEREAS**, Jeju Air was established in 2005 with the aim of making air travel  
4 convenient and affordable for passengers; and

5           **WHEREAS**, Jeju Air is a low cost Korean carrier, who launched their first  
6 international flights in 2008; and

7           **WHEREAS**, this carrier is owned by the Aekyung Group and the Jeju Special  
8 Self-governing Province and currently serves three (3) domestic destinations in  
9 Korean, as well as international destinations to include four (4) cities in Japan,  
10 Bangkok - Thailand, Hong Kong, Manila – Philippines, Vietnam and now our island  
11 of Guam; and

12           **WHEREAS**, Jeju Air has grown from two (2) million passengers and 20,000  
13 flights in 2008 to being the first Korean carrier to achieve ten (10) million passengers  
14 cumulative in 2012; and

1           **WHEREAS**, Jeju Air begins daily flights from Incheon-Seoul to Guam with an  
2 inaugural flight on Thursday, September 27, 2012; and

3           **WHEREAS**, Jeju Air utilizes the B737-800 aircraft from The Boeing  
4 Company, the world’s largest aircraft manufacturer flights from Incheon-Seoul to  
5 Guam have the capacity from 1,302-2,042 seats, which will increase the opportunity  
6 for Guam to welcome visitors from Korea, allow Guam to diversify its tourism  
7 industry and benefit our island’s economy; now therefore, be it

8           **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Unu Na*  
9 *LiheSlaturan Guåhan* does hereby, on behalf of *I LiheSlaturan Guåhan* and the people  
10 of Guam, recognize and congratulate Jeju Air on their Inaugural flight from Incheon-  
11 Seoul to Guam; and does further commend Jeju Air for this expansion and the  
12 increased opportunity for Guam to welcome additional visitors from Korea,  
13 diversifying and strengthening our tourism industry and benefitting our island’s  
14 economy; and be it further

15           **RESOLVED**, that the Speaker and the Chairperson of the Committee on Rules  
16 certify, and the Legislative Secretary attest to, the adoption hereof, and that copies of  
17 the same be thereafter transmitted to Jeju Air; the Guam Visitors Bureau; the Guam  
18 International Airport; and to the Honorable Edward J.B. Calvo, *I Maga'lahaen Guåhan*.
