4 Tax Processing Supervisor in the Taxpayer Service Division and has been with the
5 Department of Revenue and Taxation (DRT) for the past forty (40) years; and

6 WHEREAS, Ms. Benavente began her career at the Department of Revenue and
7 Taxation (DRT) as a Clerk II on September 10, 1972 after her transfer from the
8 Department of Labor (DOL); and

9 WHEREAS, Ms. Benavente was a Clerk II with the Income Tax Assistance &
10 Processing Branch (ITAPB) until November 29, 1976 where she was promoted to
11 Clerk IV within the ITAPB; and

12 WHEREAS, Ms. Benavente was promoted to Tax Processing Technician I and
13 then reclassified to a Revenue Officer I in the ITAPB on July 7, 1980; and

14 WHEREAS, Ms. Benavente was again promoted on July 8, 1982 to a Revenue
15 Officer III in the ITAPB; and

1 **WHEREAS**, Ms. Benavente was reallocated to the Business Privilege Tax Branch
2 (BPTB) as a Business Privilege Tax Service Specialist II on October 2, 1984 until July
3 17, 1986; and

4 **WHEREAS**, Ms. Benavente is married to the Vice-Mayor of Dededo, Mr. Andrew
5 Peter “Daigo” Benavente and together they have four (4) children; Joileen, Peter,
6 Dana, and Tara; now, therefore, be it
