4 Guam in numerous capacities throughout the years, including service  
5 as an elected official for the Territorial Board of Education, and also as  
6 an elected official of the Consolidated Commission on Utilities; and

8 Gloria B. Nelson has displayed exemplary service for the island and the  
9 people of Guam, and the Committee on Rules of *I Liheslatura* desires to  
10 conduct a state funeral to honor the late Mrs. Nelson, in order to  
11 memorialize the many contributions she has made in numerous  
12 capacities throughout her lifetime; and

13 WHEREAS, as set out in *I Mina' Trentai' Unu Na Liheslaturan*  
14 *Guahan's* Standing Rules, the Committee on Rules hereby authorizes  
15 expenditures for the state funeral of the late Glora Borja Nelson; now

2 a State Funeral for the late Gloria Borja Nelson in accordance with the  
3 provisions of Title 1 Guam Code Annotated Chapter 4 § 419, and the

5 *Guahan*; and be it further
