1           **BE IT RESOLVED BY *I MINA' TRENTAI UNU NA LIHESLATURAN***

3           **WHEREAS**, the Honorable Mayor Jose "Pedo" T. Terlaje was elected  
4 Mayor of the Municipality of Yona in 2000, and upon taking his Oath of Office on
