1 **BE IT RESOLVED BY *I MINA' TRENTAI UNU NA LIHESLATURAN***
2 ***GUÅHAN*:**

3 **WHEREAS**, the Honorable Mayor Dean D. Sanchez was elected Mayor for
4 the Municipality of Umatac in 2008, and upon taking his Oath of Office on January
5 5, 2009, Mayor Sanchez began serving the people of Umatac; and

6 **WHEREAS**, prior to serving the people of Umatac as Mayor, the Honorable
7 Dean D. Sanchez was employed as the Administrative Assistant from January 9,
8 1989 to July 5, 1991 during the term of the late Former Mayor Albert T. Topasna;
9 and

10 **WHEREAS**, upon the untimely passing of the late Honorable Albert T.
11 Topasna, the Honorable Dean D. Sanchez was appointed by the Honorable Joseph
12 F. Ada, Governor of Guam to serve as Mayor for the Municipality of Umatac; and

13 **WHEREAS**, following his appointment as Mayor from July 5, 1989 to
14 January 4, 1993, Mayor Sanchez returned to serve the people of Umatac as the
15 Administrative Assistant for then Mayor Daniel Q. Sanchez;

1 **WHEREAS**, during his tenure in office, Mayor Dean D. Sanchez served the
2 people of Umatac and the people of Guam in a most honorable and exemplary
3 manner, ensuring that the health, safety and general wellbeing of the residents of
4 Umatac were attended to; and

5 **WHEREAS**, during his tenure in office, and in addition to his duties and
6 responsibilities as Mayor of Umatac, the Honorable Dean D. Sanchez served as a
7 Member of the Commission on Self Determination; Member of the Guam Product
8 Seal Task Force; Member of the Department of Agriculture Aquatic & Wildlife
9 Resources - Fisheries; Member of the Civilian/Military Task Force; and Member
10 of the Association of Mariana Islands Mayors Vice Mayors and Elected Municipal
11 Council Members (AMIM);

12 **WHEREAS**, Mayor Dean D. Sanchez's membership in the Mayors'
13 Council of Guam will expire on on January 7, 2013 concurrently with his term as
14 Mayor of the Municipality of Umatac having served one (1) term as Mayor; and
15 now, therefore be it

16 **RESOLVED**, that *I Mina' Trentai Unu Na Liheslaturan Guåhan* does hereby
17 on behalf of the people of Guam extends a sincerest *Un Dangko'lo Na Si Yu'os*
18 *Ma'åse* to the Honorable Dean D. Sanchez, Mayor of Umatac for four (4) years of
19 exemplary service, contribution and support to the people of Umatac, to the
20 Mayors' Council of Guam and to the People of Guam as a whole, and wishing him
21 the very best in his future endeavors; and be it further

22 **RESOLVED**, that the Speaker certify, and the Legislative Secretary attest to
23 the adoption hereof, and that copies of the same be thereafter transmitted to the
24 Honorable Dean D. Sanchez, Mayor of the Municipality of Umatac; to the Mayors'
