3           **WHEREAS**, Rosa M. Benavente, originally from the village of Merizo, now  
4 from the village of Dededo, was born in 1942 to Jose M. Mansapit and Joaquina S.  
5 San Nicolas; and

6           **WHEREAS**, Rosa is married to Manuel Benavente; and

7           **WHEREAS**, from 1971 to 1973, Rosa held the position of Clerk I with the  
8 Department of Revenue and Taxation, later transferring to the Department of  
9 Administration; and

10          **WHEREAS**, from 1981 to 1982, Rosa was an Accounting Clerk with the  
11 Department of Labor's Guam Employment Service; and

1           **WHEREAS**, from 1982 to 1988, Rosa was promoted to the position of  
2 Employment Development Worker II for the Work Incentive Program of the  
3 Department of Labor; and

4           **WHEREAS**, from 1988 to 1995, Rosa transferred to the Guam Employment  
5 Service where she assisted numerous job seekers in finding gainful employment; and

6           **WHEREAS**, from 1995 to 2012, Rosa was promoted again to the position of  
7 Employment Development Worker III with the Alien Labor Processing &  
8 Certification Division where she assisted employers by handling Temporary Labor  
9 Certifications needed for the employment of H-2B workers in Guam; and

10          **WHEREAS**, for a significant portion of her professional life, Rosa has  
11 dedicated herself to the wellbeing of the people of Guam via workforce development,  
12 assistance to employers in helping fill critical workforce needs and by enforcing labor  
13 laws through the labor certification process; and

14          **WHEREAS**, in December 2012, Rosa has decided to retire after thirty-three  
15 (33) years of public service, and has left a positive mark on our island community as a  
16 whole, and her colleagues, family and friends wish her the best on this well-deserved  
17 retirement; now, therefore, be it
