1        **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**  
2 ***MINA'TRENTAI KUÁTTRO NA LIHESLATURAN GUÁHAN:***

3        **WHEREAS**, pharmacy is one of the oldest of the health professions concerned  
4 with the health and well-being of all people. The Guam Pharmacists Association joins  
5 with pharmacists across the nation to celebrate "American Pharmacists Month" during  
6 October 2017 with the theme "Know Your Pharmacists, Know Your Medicine", by  
7 hosting various activities and events to celebrate the profession of pharmacy; and

8        **WHEREAS**, pharmacists have extensive education and expertise on drugs and  
9 medication therapy, which makes them ideally suited to work collaboratively with  
10 patients and their health care team members to improve medication use and outcomes.  
11 They are best positioned to be health care professionals to help patients improve their  
12 adherence to their medications, and provide patient care services that ensure optimal  
13 medication therapy outcomes; and

1           **WHEREAS**, today, both Locally and Nationally, there are seventy-four (74)  
2 licensed pharmacists and one hundred twenty-seven (127) pharmacy technicians on  
3 Guam and more than three hundred thousand (300,000) pharmacists licensed in the  
4 United States providing services to ensure the safe and effective use of all  
5 medications. Today’s powerful and complex medications require greater attention to  
6 the manner in which they are used by different patient population groups – both  
7 clinically and demographically; and

8           **WHEREAS**, the Guam Pharmacists Association was formed to improve and  
9 promote public health; foster and encourage inter-professional relations; improve and  
10 advance the art and science of pharmacy; promote the aims and objectives of  
11 pharmacies on the island of Guam; support a system of education, professional  
12 training and licensure which will assure the public of the availability of competent  
13 personnel to supervise the distribution and use of all drugs and therapeutic devices,  
14 and to discharge the accepted functions of the profession of pharmacy; and to  
15 establish and maintain a Code of Ethics which will assure a high standard of moral  
16 and professional conduct for member pharmacists in professional relations with the  
17 public, allied professions, and fellow pharmacists ; now therefore, be it

18           **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Kuåttro Na*  
19 *Lihselaturan Guåhan* does hereby, on behalf of *I Lihselaturan Guåhan* and the people  
20 of Guam, recognize and commend the Guam Pharmacists Association on the  
21 celebration of "American Pharmacists Month" during October 2017 with the theme  
22 “Know Your Pharmacists, Know Your Medicine”; and does further extend a sincere  
23 Un Dångkolo na Si Yu'os Ma'åse' to them for their service and commitment to the
