WHEREAS, Mr. Thomas Bach, President of the International Olympic Committee, visits Guam on May 10, 2019; and WHEREAS, Mr. Bach was an Olympic Champion Fencer from the Men's Foil Team in Montreal 1976; and he was also a two-time World Champion Fencer from the Men's Foil Team in Montreal 1976, and then in Buenos Aires 1977; and

WHEREAS, Mr. Bach has held the position of Chairman for multiple organizations, including the Athletes' Commission of the German Committee for Competitive Sport in the German Sports Confederation (DSB) from 1979 to 1981; and

WHEREAS, Mr. Bach was the athletes' representative at the 11th Olympic Congress in 1981; and he was the individual member of the National Olympic Committee for Germany from 1982 to 1991. From 1994 to 2013, Mr. Bach was the Chairman of the Appeals Division of the Court of Arbitration for Sport; and served as a member of the International Olympic Committee Executive Board from 1996 to 2000. From 2000 to 2004, and again in 2006 to 2013, Mr. Bach was the Vice President of the International Olympic Committee; and

WHEREAS, Mr. Bach was a member of the Supervisory Board of the Organizing Committee of the 2006 FIFA World Cup; and from 2007 to 2011, Mr. Bach served as the Chairman of the Board of Trustees of the Organizing Committee of the 2011 FIFA Women's World Cup; and

WHEREAS, Mr. Bach has received numerous Honorary Professorships, as well as numerous Doctor Honoris Causa Degrees from many different countries. Mr. Bach has also received Orders of Merit from various National Olympic Committees and International Sports Organizations; and has received numerous high-level distinctions from various countries and states; and

WHEREAS, Mr. Bach was the founding President of the German Olympic Sports Confederation, serving from 2006 to 2013; and he currently serves as the Ninth (9th) President of the International Olympic Committee; and

WHEREAS, during Mr. Bach's visit to the island he will be meeting with Guam's national teams and future athletes, and tour the GNOC sports facilities; now therefore, be it

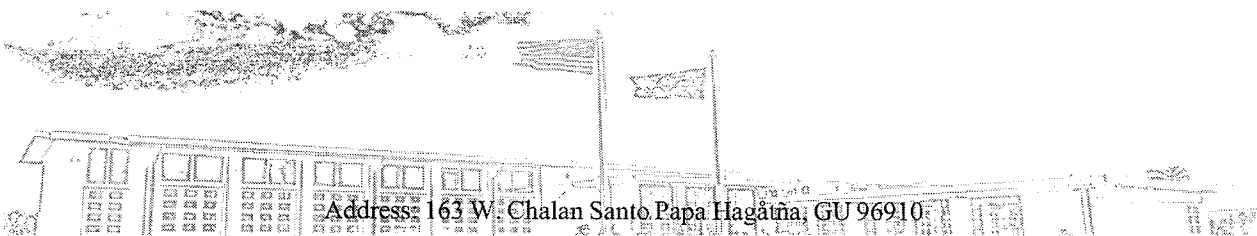


