22 the globe celebrate historical milestones. This year, the Filipino community on Guam
23 has been invited by the Philippine Consulate General in Hagåtña to commemorate the
24 122nd Anniversary of the proclamation of Philippine Independence via several online
25 events including broadcasting live Kalayaan 2020 celebrations from Manila via their
26 Facebook page and various other historical commemorations; and
