Relative to recognizing Captain Hans Sholley, United States Navy, for his fostering of a good partnership between the United States Navy and the Government of Guam; and commending him for his leadership and contributions to the island community.

BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I MINA'TRENTAI SINGKO NA LIHESLATURAN GUÅHAN*:

WHEREAS, Captain Hans Sholley, United States Navy, a former resident of upstate New York, arrived on Guam to assume command of the U.S. Naval Base Guam, where he served from 2016 to 2018 and was an integral part of the close partnership between the government of Guam (GovGuam) and the U.S. Navy; and

WHEREAS, Captain Hans Sholley graduated from the United States Naval Academy in 1992 and is an unrestricted Naval Aviator. He flew the SH-60B Seahawk (LAMPB Mk II) helicopter throughout his operational flying career, as well as having over three thousand three hundred (3,300) hours in various maritime aircraft, including the UH-3H, the C-12B, and the TH-57B/C; and his operational tours include the HSL-46, the HSL-45, and the HT-8; and

WHEREAS, from 2010 to 2011, Captain Sholley commanded the Eightballers of Helicopter Training Squadron Eight at NAS Whiting Field, where he trained unrestricted Naval Aviators for service in the fleet; and

WHEREAS, Captain Sholley's sea duties include the two (2) tours he served aboard the USS Bonhomme Richard (LHD 6), first as the Aircraft Handling Officer where he qualified as Officer of the Deck; and most recently, as the Air Officer aboard the United States Navy's only forward-deployed amphibious assault ship in Sasebo, Japan. His other sea tours were aboard aviation capable ships, to include the USS Robert G. Bradley (FFG-49), the USS Caron (DD-970), the USS Mustin (DDG-89), and the USS Lake Champlain (CG-56); and

WHEREAS, Captain Sholley is a graduate of the Naval War College and he was assigned to the Operational Plans and Force Development Directorate (J-7) on the Joint Staff in Washington D.C. where he served as a Battle Watch Captain in the National Joint Operations and Intelligence Center. Captain Sholley's shore assignments include serving tours at NAS Key West, the Joint Staff, and as a Senior Faculty Member at the Naval War College in Newport, Rhode Island; and

WHEREAS, while serving as the Commanding Officer of U.S. Naval Base Guam, Captain Sholley maintained a close relationship with the Mayors of local villages and community leaders on Guam, sponsoring events to commemorate the historical links between the U.S. Navy and the local community; and under his leadership, the U.S. Naval Base Guam was recognized as the runner-up for the "Commander, Navy Installations Command (CNIC) Installation Excellence Award" in 2017; and

WHEREAS, Captain Sholley never shied away from engaging in local discussions regarding the preservation of cultural artifacts, the protection of endangered species, the return of land, visas for temporary workers, and the relocation of United States Marine Corps units to Guam; and he galvanized a coalition of the U.S. Department of Defense (DoD) and the local government and local business enterprises that supported the recovery of the USS Theodore Roosevelt (CVN 71). He was also present at various government meetings, including legislative roundtables and public hearings, as well as participating in government groups like the Civil Military Coordination Council; and he was a standing member of the Seventy-fifth (75th) Liberation Day Planning Committee; and

WHEREAS, Captain Hans Sholley also worked tirelessly during typhoons affecting Guam to ensure that the preparations and recovery actions by DOD and GovGuam were coordinated; and

WHEREAS, Captain Sholley's personal awards include the Legion of Merit, the Defense Meritorious Service Award, the Meritorious Service Medal, the Navy Commendation Medal, and the Joint Service Achievement Medal, as well as numerous unit and campaign awards; now therefore, be it

RESOLVED, that the Committee on Rules of *I Mina'trentai Singko Na Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people of Guam, recognize Captain Hans Sholley, United States Navy, for his fostering of a good partnership between the United States Navy and the Government of Guam; and commend him for his leadership and contributions to the island community; and be it further

8 46, the HSL-45, and the HT-8; and

9 **WHEREAS**, from 2010 to 2011, Captain Sholley commanded the Eightballers
10 of Helicopter Training Squadron Eight at NAS Whiting Field, where he trained
11 unrestricted Naval Aviators for service in the fleet; and




