1 **BE IT RESOLVED BY *I MINA'TRENTAI SINGKO NA LIHESLATURAN***
2 ***GUÅHAN*:**

3 **WHEREAS**, Gerald C. Leon Guerrero was born on August 6, 1982, to Jose T.
4 Leon Guerrero and Cecilia C. Leon Guerrero in the village of Tamuning, Guam. He
5 attended Saint Anthony Catholic School for most of his early education and received
6 his high school degree from Simon A. Sanchez High School; and

7 **WHEREAS**, After, graduating from Simon A. Sanchez High School in 2000,
8 Gerald Leon Guerrero decided to answer his nation's call to service and enlisted in the
9 United States Air Force (USAF) in 2001. Shortly after making this life-changing
10 decision, Gerald Leon Guerrero resolved to make a similar commitment to his future
11 wife Noelani Iglesias Leon Guerrero. Over the next 18 years of their marriage they
12 would have two children Cque Juan and Deja-Leialoha Leon Guerrero; and

13 **WHEREAS**, As one of our island community's proud members in uniform,
14 Gerald Leon Guerrero has excelled during his nearly 20 years of military service and

1 has participated in several high-profile military operations. These include: Operation
2 Enduring Freedom (2003, 2011), Operation Freedom (2003), Operations Iraqi Freedom
3 (2006), Inherent Resolve (2006, 2011, 2014), Tomodachi (2011), Freedom Sentinel
4 (2011, 2014-2015), and Operation Sustaining Peace (2018); and

5 **WHEREAS**, Gerald Leon Guerrero began his career with the USAF at his first
6 duty station in Minot, North Dakota. During his time at Minot, Gerald Leon Guerrero
7 was deployed to Qatar to participate in Operation Enduring Freedom in response to the
8 September 11, 2001 attacks on United States soil; and

9 **WHEREAS**, After taking part in Operation Enduring Freedom Gerald Leon
10 Guerrero was assigned to his second duty station in Misawa Air Force Base, Japan
11 where he would serve for four (4) years. He would later be assigned to serve his third
12 duty station in Kadena Air Force Base, Japan where he was deployed to take part in
13 Operation Tomodachi. Thanks to the efforts of the 24,000 US servicemen like Gerald
14 who participated in operation Tomodachi the United States Armed Forces was able to
15 successfully respond to the humanitarian crisis that was caused by the 2011 Tohoku
16 earthquake and tsunami; and

17 **WHEREAS**, After completing his service in Japan, Gerald Leon Guerrero was
18 assigned to his fourth duty station in Cannon Air Force Base, New Mexico. During his
19 time in Cannon Air Force Base, he was deployed to Qatar once again to participate in
20 Operation's Freedom Sentinel and Inherent Resolve in 2014. He would later be
21 deployed to Iraq the following year to partake in operation Freedom Sentinel; and

22 **WHEREAS**, Gerald Leon Guerrero is currently serving in Eielson Air Force
23 Base, Alaska as an E-6 Technical Sergeant in the USAF and will be moving with his
24 wife and children to their next station in Grand Forks Air Force Base, North Dakota in
25 the Fall of 2020. TSgt Gerald Leon Guerrero welcomes the next chapter in his military
26 career and looks forward to the new experiences Grand Forks will have to offer; and

1 **WHEREAS**, As one of our island community’s proud service members *I*
2 *Mina'trentai Singko Na Liheslaturan Guåhan* wishes TSgt Gerald Leon Guerrero well
3 and hopes that he continues to exemplify the three core values of the USAF which
4 include integrity first, service before self, and excellence in all that one does; and, now,
5 therefore be it

6 **RESOLVED**, that the Committee on Rules of *I Mina'trentai Singko Na*
7 *Liheslaturan Guåhan* does hereby, on behalf of the people of Guam, recognize TSgt
8 Gerald C. Leon Guerrero for his nearly 20 years of military service with the United
9 States Air Force; and to further commend him for his continued commitment to the
10 United States Armed Forces as he and his family await their next duty station in the Fall
11 of 2020; and be it further;

12 **RESOLVED**, that the Speaker and the Chair of the Committee on Rules certify,
