**Relative to recognizing and commending Mr. Wener Head for providing civilian first response efforts to the people of Guam and its tourists.**

1           **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**  
2 ***MINA'TRENTAI SINGKO NA LIHESLATURAN GUÅHAN:***

3           **WHEREAS,** Wener Head was born on July 4, 1974 on the island of  
4 Kapingamarangi, a municipality in the state of Pohnpei. He resides in Ipan, Talofofu  
5 with his partner LoriAnn Tomoki; and

6           **WHEREAS,** growing up in Kapingamarangi, Mr. Head always found himself in  
7 the ocean. It was how he contributed to his family. The culture on his home island is  
8 one that is centered around family values. The way of life in Kapingamarangi revolves  
9 around the familial structure. Within this structure it is important to providing for and  
10 taking care of one another; and

11           **WHEREAS,** in 1997, Mr. Head moved to Guam and worked at Duty Free as a  
12 maintenance worker. In 2005 that he returned to life in and around the ocean when he  
13 began working at Jeff's Pirates Cove. It was there that he found a reconnection to his  
14 home through the ocean; and

15           **WHEREAS,** Mr. Head is a vital part of Jeff's Pirates Cove's rescue team. Mr.  
16 Head is proficient in the use of various vehicles in the ocean. He is a part of the "sled"

1 team and also uses the kayak for rescues. He has saved ten (10) lives in his fifteen years  
2 of employment at Jeff’s Pirates Cove. Mr. Head is brave and caring, and it is in his  
3 culture to help people. He plays a critical part of a team that is strong and unwavering  
4 in its drive to help those in need; now, therefore be it

5 **RESOLVED**, that the Committee on Rules of *I Mina'trentai Singko Na*  
6 *Lihsaturan Guåhan* does hereby, on behalf of *I Lihsaturan Guåhan* and the people  
7 of Guam, recognize and commend Wener Head for providing civilian first response  
8 efforts to the people of Guam and its tourists; and be it further;

9 **RESOLVED**, that the Speaker and the Chair of the Committee on Rules certify,  
10 and the Legislative Secretary attest to, the adoption hereof, and that copies of the same  
11 be thereafter transmitted to Wener Head; and to the Honorable Lourdes A. Leon
