3 **WHEREAS**, Hanson Low was born on May 15, 1973 on the island of
4 Kapingamarangi, a municipality in the state of Pohnpei. He and his wife, Lorreta Low,
5 reside in Yoña; and

6 **WHEREAS**, Mr. Low loves the ocean. Life on Kapingamarangi is simple. The
7 culture is one that is centered on family values and where support, care, and the
8 nurturing of one's family is of utmost importance; and

9 **WHEREAS**, Mr. Low moved to Guam in 1999 and almost immediately found
10 work at Jeff's Pirates Cove where he has been employed since. Mr. Low found his home
11 away from home at Jeff's Pirates Cove. Among the members of Jeff's rescue team, Mr.
12 Low has been employed at Jeff's Pirates Cove the longest; and

13 **WHEREAS**, he attributes his will to help people to the ways of life in
14 Kapingamarangi, and it is in his nature to help people. Mr. Low is known for using the
15 kayak as his main rescue vehicle. He plays a vital role on the team and is also known as
16 one of the stronger ones. Mr. Low has saved six (6) people. He contributes immensely

1 to a team that is strong and unwavering in its drive to help those in need; now, therefore
2 be it
