



1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***
2 ***MINA'TRENTAI SINGKO NA LIHESLATURAN GUÅHAN:***

3 **WHEREAS** the vision of Employer Support of the Guard Reserve (ESGR) is to
4 develop and promote a culture in which all American employers support and value the
5 military service of their employees. The ESGR continues to be the principal advocate
6 for the U.S. Department of Defense; and

7 **WHEREAS** over one million of our fellow citizen-service members continue to
8 serve and maintain constant vigilance in order to protect our freedoms and the American
9 way of life. Standing tall amongst our military members are our nation's National Guard
10 and Reserve forces which are comprised of men and women who continue to serve with
11 great distinction; and

12 **WHEREAS** our National Guard and our Reserve continue to serve on active
13 duty on every front of the Overseas Contingency Operations. They are also a constant

1 presence in our community, as they work hard to serve our island and the nation to
2 uphold the very values in which the American way of life was created by our
3 forefathers; and
