1	BE IT RESOLVED BY THE COMMITTEE ON RULES OF I
2	MINA'TRENTAI SINGKO NA LIHESLATURAN GUÅHAN:
3	WHEREAS, one (1) in four (4) women and one (1) in nine (9) men
4	experience domestic violence each year in the United States, and many of these
5	cases are often known by members of the victim's friends, family, and community;
6	and
7	WHEREAS, these silent witnesses to domestic violence are often
8	discouraged from intervening in an emergency situation, whether it is a case of
9	domestic assault or some other form of crime; and
10	WHEREAS, the greater the number of known witnesses there are in a case
11	of domestic assault the less likely it is for them to provide assistance to a victim in
12	distress according to the bystander effect; and
13	WHEREAS, twenty-three (23) years ago on the eve of former Governor
14	Carl Gutierrez's Proclamation of October as Family Violence Awareness Month

seven-year-old Erica Mesericordia Crisostomo Aquino and her mother Therese 1 2 Crisostomo tragically lost their lives to family violence; and WHEREAS, in an effort to end the violence, and encourage witnesses 3 intervention Guam's leaders, community advocates, and the youth have taken the 4 5 opportunity to come together and give the victims of this ongoing crisis a voice: 6 and 7 WHEREAS, in coordination with the Crisostomo Family and the Judiciary of Guam Erica's House opened on November 15, 2000, providing a safe and fair 8 venue for family visitation services and creating a positive change in the lives 9 10 those affected by violence; and 11 WHEREAS, domestic violence especially family violence has been on the 12 rise in our island community. In March 2020, the number of calls to Guam's 13 resource centers had increased drastically; and according to the Guam Behavioral Health and Wellness Center (GBHWC) the 24-hour crisis hotline at GBHWC was 14 receiving around twenty-five (25) to thirty (30) calls per day, compared to the 15 twenty-five (25) calls it usually receives per month; and 16 17 WHEREAS, the spike in domestic violence is an alarming trend in our community, and as our island commemorates the 20 years of the invaluable service 18 19 of Erica's House the 23rd anniversary of the passing of Ms. Crisostomo and Erica 20 Aquino, the need for witness intervention is necessary in order address this issue; 21 and therefore be it 22 RESOLVED, that the Committee on Rules of I Mina'trentai Singko Na 23 Liheslaturan Guåhan does hereby, on behalf of the people of Guam, recognize the Guam Coalition Against Sexual Assault & Family Violence (GCASAFV) on their 24 work honoring victims of family violence through the Silent Witness Project; and 25 26 be it further
