3 **WHEREAS**, Correction Officer II, Glenn Timothy Francisco Martinez was born
4 in Oregon on September 12, 1972 to Lourdes Francisco Martinez and Vicente Mantanona
5 Martinez (Deceased); and

6 **WHEREAS**, Mr. Martinez attended Untalan Middle School and soon went on to
7 graduate at George Washington High School in 1990; and

8 **WHEREAS**, Correction Officer II, Glenn Timothy Francisco Martinez was
9 employed with the Department of Corrections (DOC), for a total of 23 plus years. He was
10 hired on June 30, 1997 and has been a loyal, hardworking, and dedicated member of DOC;
