3 **WHEREAS,** Yuk Lan Moylan was born in Hawaii to the proud parents George
4 Lim Ho and Annie Kaihe; and

5 **WHEREAS,** Yuk met the love of her life FL “Scotty” Moylan while going to
6 school and cleaning homes at Fort Shafter, Hawaii. Scotty would be doing PT and
7 wanted to impress her by running laps during her lunch time in the field. She always
8 thought what had that man done to have to run so many laps; and

9 **WHEREAS,** Yuk Lan married Francis L. Moylan on March 27, 1938. They
10 have four children: Kurt, Richard, Francis, Leioaloha. She has been blessed with 15
11 grandchildren, 31 great-grandchildren. A successful business in Hawaii in developing
12 films that Yuk Lan and spouse Francis started; and

13 **WHEREAS,** while residing in Hawaii, the military hired them to come to Guam
14 after the war to develop films taken of the outer islands; and

1 **WHEREAS**, from there, they started FL Moylan Company, Moylan Enterprises,

3 Kawasaki; and
