

Speaker Tina Muña Barnes: Si Yu'os ma'åse'. Senator Therese Terlaje, you are recognized.

Senator Therese M. Terlaje: Thank you madam Speaker. Good afternoon everyone good afternoon Mr. Taitano, thank you again for being willing to accept this position if you don't mind I'm just gonna ask you a few questions about- So the Civil Service is one of our more- the work I think is the most complex of the government boards. Senator Therese M. Terlaje: Yes?

Robert C. Taitano, Appointee: Thank you. Yes.

Terlaje: Alright, and then, the Civil Service Commission is also one of the Commission's that spends the most hours, like for example, I followed one case and that, that hearing went on for days. And they'd spent about seven to eight hours per day in that for the one person's case that went for at least three maybe five days. But they're- they're adversarial proceedings I would say, and are- So sometimes the appointees are put into a position where you know you've got a Gov Guam director who's been appointed by the Governor going against an employee and you're also an appointee of the Governor and I want to

know do you feel, you know like, you could be objective and not let, you know, your relationships with these managers or these directors influence your decisions in the case?

Robert C. Taitano, Appointee: Negative, I don't think it'll be influencing. With me I will do my best and fair to the employee that we, you know, that's what the Civil Service Commission is all about is to uphold the grievances, and you know, go by the law, actually and you have to go by legal counsel also.

Senator Therese M. Terlaje: Alright, well thank you again thanks for committing to that amount of time and that amount of work, very much appreciate it Mr. Taitano. *Si Yu'os ma'åse'* madam Speaker.

Robert C. Taitano, Appointee: Thank you ma'am.

Speaker Tina Muña Barnes: Thank you so very much Senator Therese Terlaje. I also asked Senator Pedo Terlaje, do you have any comments or questions for Mr. Taitano?

Senator Jose "Pedo" Terlaje: Robert are you familiar with the, you know, personnel robber rules?

Senator Jose "Pedo" Terlaje: Anyway, I just throw that out because your first name is Robert. So anyway, Robert I just want to say that usually when, you know, we thank you for for taking the challenge and coming forward and volunteering for this kind of difficult position. In as far as making your decision to either terminate, or you know, for employees but sometimes you've got to be humanistic and- and then again being a commission member, you need to really make your decision based on- on the rules of ethics.

Robert C. Taitano, Appointee: That's correct.

Senator Jose "Pedo" Terlaje: So, I just want to tell you, congratulation for taking the challenge, thank you.

Robert C. Taitano, Appointee: We got to, we got to.

Senator Telo T. Taitague: Yes, so of all the agencies, you know civil service what- what can you do? What can you contribute to civil service, and if you had an opportunity do you see any issues currently right now in civil service that you would- also would like to address?

Robert C. Taitano, Appointee: No not at this time ma'am, not at this time. I would have to get foot wet and maybe you know if I do identify these discrepancies or big iffy I will bring it up to the attention to- higher ups or down to you guys- the legislature for subject change in the process- I know that process is- is somewhat hectic and it's a very complex, so I'm willing -

Senator Telo T. Taitague: Yeah, it's okay, you're- you're kind of breaking up a little bit Robert but I think- I think I get the gist of what you're trying to say and I appreciate it. So, my last couple of questions would be have you ever worked for the government of Guam? Before I looked at your background it's mostly in military and private sector, but have you ever really dabbled in government of Guam?

It is a very difficult area besides you know parole board civil service is very difficult and it- it does require a lot of good insight reading understanding you know on both- not only on the government side but on the person with a grievance, as well, and to be fair all around because that's what I'm expecting of you is to be fair you know all around.

Robert C. Taitano, Appointee: That's correct.

Senator Telo T. Taitague: So again, thank you so much Robert take care. Si Yu'os ma'åse'.

Robert C. Taitano, Appointee: You too, thank you ma'am for your time.

So I just want to say *Si Yu'os ma'åse'* and you have my support Mr. Taitano.

Robert C. Taitano, Appointee: Thank you, thank you for your time.

Speaker Tina Muña Barnes: Thank you senator Torres. Senator will Castro you are recognized.

Senator Wil M. Castro: Thank you madam Speaker. *Håfa Adai* Mr.- Mr. Taitano and congratulations on accepting the appointment by the Governor of Guam to serve as a member of the Civil Service Board. And what we did was manage the priorities first for parts for planes and problem areas to our debriefing with the unit commanders. So, I'm pretty- I've- I've attended some classes also on management.

Senator Kelly Marsh Taitano (PhD): *Si Yu'os ma'åse'* for providing that additional detail. It helps me understand your background a little bit more and some of the nuances of what you offer. Along with my colleagues I thank you for accepting or being willing to be part of this commission and all that it demands for the better of our community. *Si Yu'os ma'åse'* madam chair.

Robert C. Taitano, Appointee: Thank you for your time ma'am.

Speaker Tina Muña Barnes: Thank you Vice Chair Taitano. With that being said, again Mr. Taitano knowing your background looking at your background and looking at the leadership classes; but more importantly seeing that you do have top-secret clearance, and seeing the work that you have done, and you continue to work through the private sector for many years, but more or less, being retired and wanting to continue to give your time to the community is an appreciation that you know is going to be good for our island as it relates to your- your fairness, as it relates to the cases that you will have to be dealing.

There's going to be a lot of reading, there's going to be a lot of- literally taking the time to look at the situation beforehand and making those honest decisions. And I know that with the leadership training with the communications training, and then of course what you've gone through I think you do have the requisites needed to- to do this appointment. And I want to say I congratulate you for stepping up to the plate. I thank you for that and also to say to my colleagues I will give you my vote in the upcoming session. We do hope that- that the reports will be expedited, and that we will have you in the session agenda. So Taitano, I want to say thank you again for your time and Si yu'os yan un Bindisi todus hamyo!


