II. SUMMARY OF TESTIMONY & DISCUSSION:

This public hearing was Called-to-Order @ 9:00 a.m.

Chairman Joe S. San Agustin: The Committee on General Government Operations, Appropriations, and Housing will Continue this public hearing. Now we will proceed to Bill 210-35 that was introduced by Senator Therese Terlaje senator if you could please give your opening statement on your bill thank you

Senator Therese M. Terlaje: Thank You Mr. Chair this bill is an act to appropriate the balance of the hospital Capital Improvement Fund to the Guam Memorial Hospital Authority for capital improvement projects as you know this fund was created during the recent budget in the recent budget law and it sets aside ten million dollars of excess 2019 revenues for capital improvement projects at the hospital which were not funded at all in the 2020 budget so we all know that GMH has had numerous long-standing ongoing challenges which include the maintenance of its old facility and there have been some improvements to GMH but many challenges so for two fiscal years in a row gmh was denied funding requested for capital improvements and appropriated significantly less than its total budget requests in 2019 gmh requested a total budget of 242 thousand (\$242,000) but only received 30 I mean sorry 242 Million (\$242,000,000) but only received 30 million (\$30,000,000) this appropriation did not include funding for capital improvements in 2020 GMH requested a total budget of 190 Million (\$190,000,000) but only received 28 million (\$28,000,000) earlier this year GMH leadership during their oversight hearings and again in budget hearings were asked to identify their top three urgent capital improvement projects and they did and they stated that these were the roof repair and the electronic health records which was a CMS requirement and the electrical panel at the hospital they have made efforts to address some of these items and but the HER primarily has been not yet addressed ten million dollars according to GMH will be far short of what it needs to complete the electronic health record system but I think they need in order to proceed with procurement of a record system or even what it will need to proceed with the procurement for example experts or other to develop the RFP they will need money as soon as possible that the deadline for the electronic health record system the company that currently manages this system is phasing out this system so gmh will be unable to remedy any issues that come up or address any issues with their HER and thus it puts GMH at risk for losing the centers for a Medicare accreditation and thus puts GMH at risk for losing Medicare money and that's really the goal here is to make sure that GMH never loses its Medicare accreditation because the government of Guam quite frankly will not be able to afford what Medicare is currently providing gmh and so we need to ensure that that funding sources is secure by complying with the CMS requirements so this bill again Mr. speaker is to ensure that the fund that was created during the budget law says that the ten million (\$10,000,000) will be deposited there and this bill is to take the money out from this Capital Improvement Fund and allocate it specifically to replace the electrical panel

necessary generator to repair the roof and to procure an electronic health record systems Si Yu'os ma'åse' Mr. speaker.

Chairman Senator Joe S. San Agustin: Thank You senator Terlaje we have two individuals that have signed up in support of this bill we have Mr. Sedfrey Linsangan and Mr. Ken Leon Guerrero but I know Mr. Leon Guerrero had to depart but I like to also continue to recognize my college that that are still here Senator Moylan Senator Kelly Marsh Taitano, senator "Pedo" Terlaje, Senator Clynt Ridgell and Senator Telo Taitague Mr. Linsangan please sir.

Mr. Sedfrey Linsangan: Thank You Mr. chairman good morning to all of you noble senators I have a happy Thanksgiving yesterday and I hope all of you as well yes, I support this bill to release the balance of the fund to GMH for the capital improvement projects specifically, for the three issues that Senator Terlaje mentioned well in case of the electrical panel GPA have inspected this panel a few months ago and they stated that it's still good and the technology now you can buy refurbished parts that are still okay or the new parts so why do you have to spend eight million (\$8,000,000) or ten million dollars (\$10,000,000) for a new electrical panel second to repair the roof well what they're doing is wrong see what they did is put styrofoam on the loop and pass the concrete just not the right way to repair the roof you know based on my experience because I have houses in Philippines and here every time we have leak on the roof, we scrape or expose the cracks on the roof Grind it or stand it and then you grind the part of the crack and inject epoxy adhesive it will sit and plot all the place that is needed to repair that's the proper way not patching and patching that's why we will have the same problem because they're doing the wrong thing we just spend the money and it's not hard to do that you know even their own people can do that they can order the material here and they're making it a big issue reminds me of the old saying if you want something done there's so many ways if you don't want something done there's so many alibis for reason you know sometimes if the intention is to build a new hospital they'll memory pair up you think they'll never make it right they will stage an act that is no good it will collapse but you see the hospital is only built in 1977 based on the report they Post newspaper we are now in 2019 2019 - 1977 is what named 42 years only the hospital imagine only 42 years then they just saw some cracks on the columns on the floor they said oh it will collapse how many years they've been saying that for almost ten years they even Condemn one of the building they just saw the column one of the column concrete just some cracks in the rebar showing oh it's already going to fall down it's a matter of life and death that's a lie big lie you know they don't even have any what any certification from engineering firm that they had their certification to condemn it to justify their action those are just acts to just give the new hospital in other country videos one says new projects so they can have a cut or Commission sometimes I'm thinking like that my positive instinct is telling me oh they want a Hospital a state-of-the-art hospital but made on the hard rain my negative instinct is telling me they want a cut or Commission that's why am i did a lot that 500 or 700 million (\$700,000,000) again you will drain the Borrowing capacity of the government you know and then what you want to do you got to increase the peace again the taxes the property tax the GRT just me frustration with this government and even with the pass administration they're trying to stage an act so many buildings where demolish just like the administration building in front of the police department and then rent to the private company they demolished JFK and then Rent

again to that private company this even will be even paying the maintenance Why you have to pay the maintenance of releasing the property that will paying 1 million dollars for the maintenance you know some things to think about the senators because these are just easy if you will help if you, they have good intention it deleted have good intention everything will be in order.

I would like to suggest Mr. senator since you're limiting us to five minutes I hope you will also consider limiting the questioning by your colleagues through five minutes only you know because you know there's people also you know waiting you know for the other bills and it's just Fair and Square equal protection of the law that you also limit the questioning just like the US Senate the US senators with a question the people making testimony after they make the make justice upon they're all is limited to two minutes or five minutes anyway if they want more questions then they need to schedule an oversight hearing this just my piece your honor senators and I hope you know reminds me of the leaning tower because it just problem with the hospital it will lean no just problem is a structural hospital it will live just like the PISA leaning tower in Italy I've been there so many times in Europe and they preserve the building like 1,000 years, 500 hundred years, 800 hundred years but I'll see you would like the demolished building instead of preserving it as if we have a lot of money in the world Thank You Mr. senator.

Chairman Senator Joe S. San Agustin: Thank You Mr. Linsangan Senator Moylan do you have questions on Bill 210 no Senator Kelly Marsh, no Senator Pedo no Senator Clynt thank you I know senator Telo has that's the task force.

Senator Telo Taitague: Thank You Mr. chair and thank you for your testimony today I am support of this definitely we are I think many of my colleagues are in support of this measure and reading through it understanding the issues I'm just concerned Mr. chair that you know BBMR is not here as well as Guam Memorial Hospital is not here and I'm hoping that Mr. chair that we can get some kind of testimony from them it'd be very helpful is my comment but I'm totally support of this bill and thank You.

Chairman Senator Joe S. San Agustin: Thank you Senator Telo and yes GMH has responded that they will be submitting testimony but we're going to find out what's their next excuse the money is ready in the budget the money is there just a matter of transferring that what this bill will do and before I ask the author of the bill to speak I like the first maybe I can ask a few questions or actually make a few statements number one what I'm concerned about is that I'm in full support of this bill I want to get the hospital fixed but what surprised me the most is that the priority is to fix the cracks in the roof the cracks on the roof at GMH has been covered under insurance the now the insurance company won't pay and that bothers me because if I'm correct Guam Memorial hospital is still being shirt by the same company and renewed it but they're not getting paid and I'm going to have to ask that question now ask that separate separately on the oversight the oversight chair to maybe take a look at that because if they're going to keep going after the same insurance to be insured and you can get coverage then they need to stop they need to think about that because Exact what Mr. Linsangan says because when they did repair the cracks and they put the foam they shouldn't have done that on their own unless they got clearance from their insurance to make sure

that's what they repair and then on the issue of the electrical panel I agree with you totally Mr. Linsangan but the statement they made and the last oversight but it's not really that the panel is broken it's because it's too close to the boiler the risk has hazardous the threat to the employees and to patients that's the threat is they need to move the panel away or move the boiler it's too close to water that was the reason why and I have nothing else more to say and I'd ask the oversight chair then the sponsor bill to make her statement and we can move forward.

Senator Therese M. Terlaje: Thank You Mr. chair Thank You Mr. Linsangan for your testimony today I hear you and I agree with you that it is frustrating when we hear different messages mixed messages sometimes especially over the years whether it's urgent then it turns to not urgent versus we are putting patients you know at risk but yet you know we don't have to pursue this for I don't know how long so it is very concerning to me that GMH is not here DOA is not here or BBMR not here because I don't think the money has been deposited into this fund at this point although the law says it shall be deposited and so we may hear you know we're going to wait until the audits done we're going to wait until we pay eightythree million dollars (\$83,000,000) in deficit before this money gets deposited I'm not sure but I really appreciate that there are mixed messages and what the legislature and the people of Guam need and deserve is a very clear message are we going to fix this even if we're going to build a new hospital are you going to fix the roof for the next five years or are we going to continue to have leakages while we have patients in critical care there those types of questions I just I believe GMH was being very consistent about their capital improvement needs but I'm just concerned that they're not here today and what that what the message is you know in that regard but I think that you know regardless of any other concerns we know that CMS has put it in writing they need to fix their electronic health records and this is going to help patient care across the board everybody agrees private physicians they want to hook up to that also, and so if we could find a way that would set this you know superhighway for Guam electronic health records that's even better but at the minimum we've got to set it up for GMH in order to meet this CMS requirement and that I think is urgent I don't want to hear another story in the news about the data system you know stopped operating and we they were unable to fix it so I just think I think we have to focus on patient care we need to focus on what are we going to do regardless of whether we build or we don't bill are there minimum you know requirements for this facility that we are trusting our families - you know receive good quality care and I think they are doing their best with this facility and I commend them for that but I think all of us and in leadership we need to be consistent and so I hope that the money will be deposited the next time we check that it will be deposited as required by the law and that we know will not have a legal battle and in that regard and I hope that my colleagues will support this bill to take that deposited money and put it into these improvements that need to be made right away and that GMH of course will do.

I'm hoping that they will do their part to do as the chairman has said - to follow up with this insurance company that has denied you know covering roof that they will follow up you know in all the other things and be consistent whether GPA has fixed the electrical or you know they're still going to invest in moving it at this point or not and I know they said they're there waiting for this Army Corps of engineer assessment on many things but the Army Corps

made it very clear I mean they see the same things that we've all seen for many years and so it's just a matter but they've also made it very clear that their estimate to build a new hospital even if that is the plan at a cost of what seven hundred million dollars that that would be that we could not shortcut the next five years of you know critical urgent needs and so I just I just want to see the government to be consistent in this regard Si Yu'os Ma'åse' again Mr. Linsangan Mr. chairman.

Chairman Senator Joe S. If As reflected in the September 2019 Consolidated Revenue & Expenditure Report (CRER), total gross General Fund (GF) revenue collections in FY2019 was approximately \$798,066,773, or \$22,437,805 over the adopted GF level of \$775,628,968 in P.L. 34-116. However, it is important to note that the FY2018 Government of Guam Audit reflect a cumulative deficit of \$33,443,863. Due to the cumulative General Fund shortfall of \$33,443,863, the Bureau does not recommend any appropriation of revenues collected in excess of the adopted FY2019 General Fund levels contained in P.L. 34-116 as it is not fiscally prudent. Appropriating from such a source will hinder the Government of Guam's ability to reduce the cumulative General Fund deficit. Therefore, the Ten Million Dollars (\$10,000,000) of Fiscal Year 2019 income tax and business tax revenues in excess of those levels set forth in Public Law 34-116, should not be deposited in the Hospital Capital Improvement Fund due to the aforementioned controllars GE deficit.

The Office has received Bill No 210-35 (COR), AN ACT TO APPROPRIATE THE BALANCE OF THE HOSPITAL CAPITAL IMPROVEMENT FUND TO THE GUAM MEMORIAL HOSPITAL AUTHORITY FOR CAPITAL IMPROVEMENT PROJECTS.

Bill No 210-35 seeks to appropriate the balance of the Hospital Capital Improvement Fund as enacted in the FY 2020 Budget (P.L. 36-35), Chapter III, Part 1, Section 5, to the Guam Memorial Hospital Authority for the purpose of funding capital improvement projects within GMHA. The sum of \$10,000,000.00 is funded from the FY2019 income tax and business privilege tax revenues collected in excess of those revenue levels set forth in Public Law 34-116 for both categories combined. Excess revenues are estimated at \$22 Million based on the CRER report as of September 30, 2019.
