Dear Senator Terlaje:

Buenas yan Hafa Adai! I am writing this in response to your request for clarification as well as a recommendation statement from a mental health perspective regarding the candidate's fitness for duty status after the follow up evaluation completed. Based on his clinical interview and follow up on recommendations as presented in his initial fitness for duty evaluation, Mr. Stephen Ignacio is deemed fit from a mental health perspective for consideration in the position of Guam Chief of Police.

Candidate has taken seriously the recommendations provided in his initial evaluation to include follow up with a medical clearance evaluation to ensure his health and safety. Candidate will likely have to respond both administratively and in an active law enforcement role as the Chief of Police. His previously self reported impaired health status was likely to have increased the risk to the community and to fellow officers if it was not managed successfully. The Chief of Police position is a highly stressful and physically demanding post that requires intelligence and insight regarding the impact of one's health condition and environment on decision making, tactical movement, and interpersonal relationships amongst the force. It was with great concern for both the applicant and the community that I offered my initial clinical opinion. Subsequent to that evaluation, the applicant has complied with the recommendations of that evaluation as noted by this provider to remedy these issues. Because of his successful compliance with those recommendations he is cleared for consideration of the position of Chief of the Guam Police Department from a mental health perspective with the caveat that he is to continue these efforts.
