14 Mechanical Engineering Specialist from November 1986 to June 1995 with

17 December 1986 to February 1987 and a Luboil Plant Assistant, February 1987
18 to July 1989 with Saudi Arabian Markets and Shell Lubricants Co., Ltd.,

20 **WHEREAS**, Mr. Domingo continued his ascend with Shell as a
21 Technical Sales Engineer, January 1993 to August 1995; as a Sales Technical
22 Adviser, Southern Islands, August 1995 to August 1996; then became Luboil

24 Bitumen, February 1999 to 2000; the Commercial Sales Manager, Construction,

11 and business associations, including Couples for Christ; and


12 **WHEREAS**, Mr. Ruben Mario A. Domingo has also spent much of his
