*Hafa Adai!* Senator Biscoe-Lee:

The Bureau requests that Bill No. 262-35 (COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Bill No. 262-35 is an act relative to §§40110, 40124, and 40127, all of Article 1, Chapter 40, Division 4, Title 5 Guam Code Annotated relative to procedures to fill a vacancy of the Mayor and vacancies in the Municipal Planning Council (MPC).

The proposed amendment to §40110 would appoint the Executive Director of the Mayors' Council of Guam (MCOG) as Acting Mayor of a municipality for up to ninety (90) days in the event of a municipality having vacancies for Mayor and Vice-Mayor as well as the MPC. The proposed amendment to §40124 would mandate the Mayor of a municipality to select and appoint members to the MPC within ninety (90) days of taking office. The proposed amendment to §40127 would authorize the Executive Director of the MCOG to appoint members to the MPC, with the approved vote of two-thirds (2/3) of the MCOG, in the event that a vacancy in the MPC occurs for more than ninety (90) days.

As such, the Bill is administrative in nature and poses no fiscal impact upon any funds of the Government of Guam.
