Bill 245-35 (LS) is an act to ad §4101.2 to Chapter 4 of Title 4, Guam Code Annotated relative to establishing the Swift Appointment Modernization Act of 2019, which would allow for the expedient recruitment and hiring of law enforcement officers. The proposed legislation intends to facilitate such purpose by increasing the list of applicants made available to qualified law enforcement agencies, reducing the appeal period timeline, and allowing qualified law enforcement agencies a continuation of interviews.
