The Bureau requests that Bill No. 352-35 (COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Bill 352-35 (COR) is an act to add a new §4125 to Chapter 4 of Division 1, Title 5, Guam Code Annotated, relative to providing for transparency and accountability in the use of U.S. Government and Government of Guam funds for COVID-19 response efforts, by requiring weekly financial reports. The proposed legislation intends to facilitate such purpose by requiring the Directors of the Department of Administration, Bureau of Budget & Management Research, and Revenue & Taxation to certify said reports and transmit to the Governor of Guam and Guam Legislature no later than five (5) business days after the end of each week.

As such, the Bill is administrative in nature and poses no fiscal impact upon any funds of the Government of Guam.
