Legislative Bill No. 146-35 (COR) seeks to amend §11105 of Chapter 11, Title 12, Guam Code Annotated, relative to allowing the Public Defender Service Corporation to receive and administer grants and enter into intra-governmental and inter-governmental agreements to provide legal services for under-represented groups and for the purpose of establishing an Elder Law Center.
