## BUREAU OF BUDGET AND MANAGEMENT RESEARCH COMMENTS ON BILL NO. <u>253-35 (COR)</u>

The proposed legislation intends to amend §28202 of Article 2, Chapter 28, Title 17 of the Guam Code Annotated (17 GCA), relative to the benefits of students entitled to merit awards, by grandfathering existing recipients of merit awards from the Student Financial Assistance Fund from changes in benefits made through P.L. 34-151. It also intends to expand the applicability of the merit awards from only tuition and fees to include total cost of attendance.

As a result of P.L. 34-151, §28202(a) mandates the application of Federal Pell Grants against the recipient's tuition and fees prior to expending from the Student Financial Assistance Fund. This process allows for more students to benefit from the Student Financial Assistance Fund. The proposed legislation seeks to reverse the order of the application of funds against tuition and fees and first apply the merit awards from the Student Financial Assistance Fund Pell Grant. Further, the remaining balance from the total cost of attendance (as contained in the recipient's Free Application for Federal Student Aid) after the tuition and fees are paid will then be disbursed from the Student Financial Assistance Fund after subtracting the recipient's Federal Pell Grant award.

The proposed legislation also seeks to add a provision in the affected subsections (a) Tuition and Fees at the University of Guam, and (c) Allowance for Textbooks and School Supplies, of §28202 Article 2, Chapter 28, of 17 GCA that the changes made are to take effect beginning with merit award recipients who signed the contract beginning in *Fanuchanan* (Fall) Semester of 2020. §28202(c) provides merit award recipients an additional \$350.00 per semester for textbooks and school supplies.

UOG notes that while its intent in supporting the passage of P.L. 34-151 is to make the funding for merit scholarships available to as many students as possible, several complaints from current recipients were received as a result of the change in the application of benefits. UOG anticipates the number of students that will benefit from merit scholarships to be reduced should this proposed legislation pass.
