The Bureau requests that Bill No. 29-35 (COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reasons(s):

Legislative Bill No. 29-35 is an act to amend and reenact §64.62, Article 2, Chapter 64, Title 9, Guam Code Annotated. The intent is to authorize the Mayors Council of Guam (MCOG) to draft rules and regulations to permit games of chance at the Guam Island Fair, Liberation Day Carnival, and any other fair or carnival that the Governor has issued a proclamation for.

Based on the foregoing, the provisions in Bill No. 29-35 are administrative in nature and would not fiscally impact the appropriations of FY 2019.
