## Bureau of Budget and Management Research Comments on Bill No. 351-35 (COR)

The proposed legislation seeks to establish the "Business Economic Support Program", which is intended for the distribution of unconditional, one-time cash payments to eligible micro businesses whose industry was considered non-essential pursuant to the Governor's Executive Order No. 2020-05. These one-time cash payments would have the lowest denominator of the payout be no less than Two Thousand Dollars (\$2,000) and no higher than Ten Thousand Dollars (\$10,000) within the monetary tier to be included in the established rules for the administration of the Program. Furthermore, the Bill proposes to establish a fund to be known as the "Business Economic Support Fund" for the purpose of receiving deposits from which I Maga 'hagan Guahan is authorized to transfer no more than Twenty Million Dollars (\$20,000,000) from the funds received pursuant to U.S. Public Law 116-136 (The Coronavirus Aid, Relief, and Economic Security Act) to pay for the CARES Economic Support Program. Should additional funds be required, I Maga'haga shall request the approval from I Liheslaturan Guahan. All funds deposited in the Fund shall not be subject to any transfer authority of I Maga 'haga, and any funds remaining shall be subject to an approval of the transfer by I Liheslatura. It should be noted that Bill Nos. 345-35 and 350-35 also request to add an Article 14 to Chapter 1, Division 1, Title 5 of the Guam Code Annotated.

Through the CARES Act, the federal government directed approximately One Hundred Seventeen Million Dollars (\$117,000,000) to Guam to address necessary expenditures incurred and projected due to the island's response and recovery efforts for the public health emergency. These funds are to be used within the exclusive management of the Executive Branch. All grants and appropriations made by the United States federal government that provides one hundred percent (100%) of the funding to the Government of Guam for a specific project or purpose makes no provision for local legislative control. In accordance with Executive Order No. 2020-13, all agreements and invoices involving expenditures authorized pursuant to the public health emergency declared to respond to the COVID-19 pandemic shall be posted on the website of the Office of I Maga'hagan Guahan and shall be subject to review and be included in monthly reporting to I Liheslaturan Guahan. Any reporting requirements to the respective federal grantors are already in place for recipient Executive Branch departments/agencies. A budget for this CARES Act funding was developed and is guided by the U.S. Department of the Treasury's Guidance for State, Territorial, Local, and Tribal Governments that was issued on April 22, 2020. Within this budget that was transmitted to the Speaker of I Liheslaturan Guahan on May 5, 2020, funding is already earmarked for COVID-19 related economic support, including Twenty Million Dollars (\$20,000,000) for the provision of grants to small businesses to reimburse costs of business interruption caused by required closures and Twenty Million Dollars (\$20,000,000) for public assistance payments to individuals under the Prugraman Salappe' Ayudon I Taotao Program established pursuant to Executive Order No. 2020-12.
