The Bureau requests that Bill No. 42-35 (LS) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Legislative Bill No. 42-35 (COR) seeks to grant Administrative Jurisdiction of a two (2) acre portion of Parcel 5109-R2, Municipality of Tamuning to the Guam Regional Transit Authority (GRTA) for the purpose of developing and constructing a maintenance and office facility. GRTA is required to develop such facility within 3 years of such administrative jurisdiction, failing such compliance shall revert the property back to the Chamorro Land Trust. The Department of Land Management has provided a prepared, recorded survey map designating the two (2) acre of Parcel 5109-R2 to GRTA. Up to \$3.2 Million in Federal funding for such purpose is available; but 66% of this funding must be encumbered by September 30, 2019.

This proposed legislation is an administrative in nature and would not fiscally impact the appropriations for FY 2019.
