The Bureau requests that Bill No. 50-35 (COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Legislative Bill No. 50-35 is seeking to amend § 25.25(b) of Chapter 25, Title 9 Guam Code Annotated relative to specifying criminal penalties of underage sexual activity. The intent of the bill is to provide certain conditions making criminal sexual conduct a misdemeanor and not have to require individuals charged with a crime under §25.25(a)(1) of this section from mandatorily registering as a sex offender in accordance with 9 G.C.A. §89.01(d)(8).

The proposed amendments are administrative in nature and would not fiscally impact the appropriations for FY 2019.
