The Bureau requests that Bill No. 55-35 (LS) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Bill 55-35 is an act to amend §4302(c)(1)(D) and §4302(c)(1)(E) of Article 3, Chapter 4, Title 4, Guam Code Annotated relative to the composition of the Government of Guam Health Insurance Negotiating Team. The proposed legislation would provide an alternate representative for the Judicial and Legislative branches should either branch decide to enter into a health insurance contract separate from the Executive Branch. Such representative shall be an employee from the Executive Branch appointed by the Governor of Guam. The amendment does not affect the number of members serving on the Health Insurance Negotiating Team.

As such, the Bill is administrative in nature and poses no fiscal impact upon any funds of the Government of Guam.
