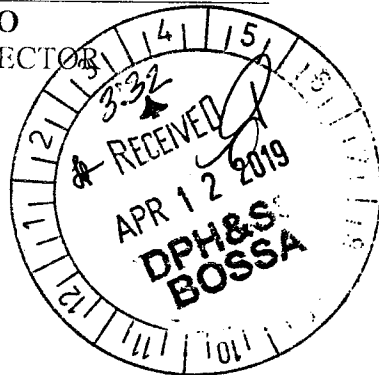

Alee I Catherine’s Home: Women’s Shelter

January 2019

During the month of January 2019, the Alee I received two hundred and seventeen (217) calls:

Twenty-one (21) possible client referral calls, to include fourteen (14) self-referrals, three (3) potential referrals from VARO, two (2) from (GLSC-DLC) and two (2) potential client referrals

from the Guam Regional Medical Center. One hundred and ten (110) active clients inquiring/giving information, four (4) past clients inquiring/giving information, fifty-five (55) calls for active clients, thirteen (13) calls for past clients, two (2) outside agency calls inquiring/giving information, three (3) program/staff related calls, four (4) calls for donation inquiry, four (4) hang ups and one (1) wrong number.

Alee I provided services for a total of eleven (11) clients for the month of January four (4) new clients, and seven (7) clients from the previous month.

Active Clients for January 2019:

Client is a forty-eight (48) year old single Caucasian woman who is a U.S. citizen. Client was assisted with transportation pick-up and drop-off services to and from client's child's school. Client was assisted with transportation services to the Guam Behavioral Health and Wellness Center (GBHWC) for client's child's appointment and to the pharmacy to obtain medication. Client was assisted with transportation services to Bank of Guam, ITC Building, employment interview, and Department of Public Health and Social Services (DPHSS). Client was also assisted with transportation services to Payless Supermarket, American Grocery, Guam Legal Services (GLS), and Attorney Brook's Office. One hundred and sixty-two (162) active clients inquiring/giving information, ten (10) calls for active clients, twelve (12) past clients inquiring/giving information, six (6) calls for past clients, eighteen (18) outside agency calls inquiring/giving information, nine (9) program/staff related calls, and one (1) hang up.

A total of sixteen (16) clients for the month of March and thirty-two (32) children; seven (7) new clients, and nine (9) clients from the previous month, were served.

Ms. San Nicolas was reminded that any structural repairs (cracks in ceiling/roof) are the responsibility of the landlord and that our landlord (Government of Guam) has been informed and we are still awaiting action. Ms. San Nicolas was informed that with the shelter being at capacity for the last few months, the stripping/waxing of the floors has not been feasible. CSS Support Services informed us that this will take two (2) days to complete and that the shelter needs to be empty while the work is being done. Ms. San Nicolas was informed that although the floors are dull, they are clean and that we will schedule the stripping/waxing at such time that the shelter is empty. Although bid specifications, Emergency Shelter Operations, Section H require the Bidder to ensure Facility is maintained and in good repair, painting and major plumbing repair is cost prohibitive. Maintenance and repairs have been limited to natural wear and tear or repair of client damages and not structural repair.




