



Re: Visa Processing and Dentistry License of Dr. Chie Hayashi

To Whom It May Concern:

We are writing to request a six-month extension of the condition that Dr. Chie Hayashi must comply with U.S. Immigration requirements before September 30, 2019. Due to business administrative matters, Dr. Hayashi's visa petition has not yet been finalized for submission. Once we have finalized the petition for Dr. Hayashi's visa, processing may take up to 8 weeks before the visa is issued.

Our legal analysis of the requirements of a work visa strongly indicates that the proposed business structure and investments meet the criteria of the work visa, and we are confident the visa will be issued. However, because of continuing business negotiations, we need an additional six months beyond the September 30th deadline to account for finalizing the petition and visa processing times.

We would appreciate the extension of the deadline to comply with the Board requirements. Please reach out to me if you have any questions.
