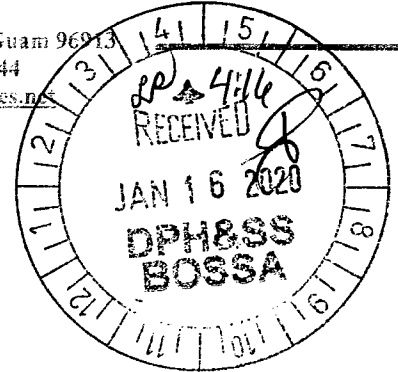

- A family of six (6) was evicted due to assaulting GSJ staff and abandoning their minor children at the shelter (case number: 102001).

**Work Assistance:**

- A Chuukese couple was assisted by GSJ with preparation of job applications and transportation to job interviews (case number: 102004).
- A Chamorro couple received financial assistance from GHC for Guam IDs in order to obtain job. They were also assisted with job applications and transportation to interviews (case number: 091955).
- A Palauan female was assisted by GSJ SW by finding an opportunity to work as a live-in-caregiver for an elderly female from OPG. This client did not make a decision on whether or not to pursue the position. (case number: 102027).
- A Chamorro female was assisted by GSJ SW with an employment opportunity as a live-in-caregiver opportunity for an elderly female. It is still under negotiation. (case number: 091932).
- A Chamorro client received financial assistance from a non-profit organization for his work boots (case number: 091955).
- A HOH of a family of five (5) was assisted by GSJ SW with financial assistance from GHC for her Passport newel. She was also assisted with applying jobs and was hired at Advance Management (case number: 122007).
- A single mom of a toddler was assisted by GSJ SW to find a job @ Daycare centers

(case number: 122015).

- A single woman got assistance from GSJ SW for an off-island job application and she was hired (case number: 122004).

**Client's Current Status:**

- **F1 (12/5-2/3/20):** A Chuukese/Chamorro common-law couple with 3 children was staying at a skate park in Dededo and are now at GSJ. They needed to renew their SNAP. They are in the process of one of their daughters transferring schools. They were both unemployed, and had been trying to find a program for their 3-year old daughter, who cannot speak. GSJ SW assisted them with what they needed, and they now have SNAP benefits, 7-year old daughter attends a near-by school, 3-year old daughter started receiving assistance from DOE Preschool Program, and HOH was employed at Advance Management. Her common-law husband, who has psychiatric disability, is receiving financial assistance of \$250/mo. from his stepfather, who is also taking care of the 3 children while HOH is at work.
- **F2+3 (12/20-2/18/20):** A Chuukese single mom with four (4) minor children. Her ex-husband had passed away leaving 3 children behind, and common-law husband is in DOC since December 5, 2019. GSJ SW is assisting her with availability of SS benefit. HOH does not have I-94 and SS card, so she cannot apply for ESG program, until the document issue is resolved. GSJ SW coordinated with Micronesian Resource Center for HOH's I-765 application, so she could apply for replacement of SS card and for GHURA Public Housing.
- **F4 (12/24-2/22/20):** A common-law Palauan couple with three (3) minor children. HOH is taking care of her children while her husband is making money from fast cash paying jobs. GSJ SW proposed them options of applying ESG program and GHURA Public Housing, as well as finding jobs and saving money.
- **F5:** A room for EH.
- **F6 (10/30/19-1/28/20):** A common-law Chuukese couple with three (3) minor children. HOH is working at 7-Day Supermarket, making about \$620 biweekly. They were #594 on Section 8 Waiting List and receiving \$1100 in SNAP benefits. They have no car payment, but were obligated with uncertain amount of GPA arrears and rental arrears of \$1200. HOH did not have birth certificate and his sons did not have SS cards. GSJ SW proposed them options of developing a payment plan to payoff back rent, clear GPA arrears, apply for the replacement of SS card and birth certificates, and then apply for ESG Program. They have since made a payment plan for back rent, cleared GPA arrears, completed ESG application, and finished GHURA Orientation. They are now waiting for Eligibility Letter from Salvation Army and another meeting with GHURA on January 9, 2020. With these progresses, their stay was extended 30 days.
- **F7 (12/24-2/22/20):** A single Chamorro mother with three (3) minor children. Though HOH applied GSJ with her boyfriend, he is not allowed to stay in the shelter until a paper work is completed, because the children are not from him. HOH is pregnant, and they are on SNAP of \$935, never applied for GHURA, and are making a living with a very limited income from the boyfriend's fast cash paying jobs. He expects to be hired at a diving company in January 2020. GSJ SW proposed options of applying for ESG program and GHURA and saving money. They are now collecting required documents for ESG program as well as applying for marriage certificate.
- **F8+9 (12/4/19-2/2/20):** A Chamorro common-law couple with 6 minor children, of which only two toddlers are from current relationship. Two rooms were provided to

this family, but HOH is not allowed to enter the other room where four older children are staying. He works at Protection Concepts Unlimited LLC, making about \$650/payday. They have completed their ESG program application before being admitted GSJ. They have SNAP benefits of \$1800 and are on GHURA Public Housing Waiting List for Amp 1 and 2 at #3 and Amp 3 at #6. Their application for Amp 3 and ESG Program were declined due to an unresolved case. They are also obligated with loan payment of \$250/payday and car insurance of \$90/m. GSJ SW proposed the options of applying for a Block Grant, making adjustments to loan payment in order to be able to save \$300 a payday, as well as, the wife finding employment. They have no savings until now, and the wife remains unemployed. She is focusing on finding ways of claiming SS benefit, life insurance, and pension from her ex-common-law husband, who passed away November 2019.

- **F10 (12/4-12/31):** A Chuukese couple with four (4) minor children. Both are employed, making \$1000/payday together. They have a savings of \$600, SNAP benefits of \$740, and are waiting for Police Clearance' issuance for Public Housing Amp 3. They are obligated with car payments of \$232/mo. and GPA arrears upwards of \$200. GSJ SW proposed to them options of saving money of \$1500/m, clear GPA arrears for them to be ready to move in Amp 3. Following their goals and with the issuance of Police Clearance, clients moved out on December 31, 2019.
- **S1 (12/10/19-2/8/20):** A Chuukese single mom with her toddler son and his grandmother. HOH is working as a caregiver of a bedridden man, and receives cash of \$66/day, making \$1320/m. They have SNAP benefits of \$280/mo. and are obligated with sending \$100-200/mo. to her disabled sister in Chuuk. GSJ SW proposed options of applying for ESG program as well as saving \$700 a month.
- **S2 (11/1-12/31):** A Kosrean married couple without children was sleeping outside the Astumbo Church. HOH, a fifty-year-old man, has medical conditions since he was in a coma for 7 weeks, so his 45-year-old wife makes fast cash from cleaning jobs. Their MIP was suspended after failing their renewal and HOH does not have a birth certificate. GSJ SW proposed options of reapplying for MIP, finding a regular job, applying for ESG program, and saving money; however, they were not able to achieve any of goals except reapplying MIP. The SW also found out the HOH was not qualified for SSDI due to lacking quarters. An offer of staying at HOH's friend's ranch in Dededo was declined by the friend's wife, but another ranch house was available on the exit date, so they moved to the ranch house.
- **S3-1 (12/10/19-2/8/20):** A Korean single woman came back after numerous utilizations of EH. In coordination with a Case Manager at SCSEP Program and GSJ SW, client found a job offer, but client declined it. GSJ SW offered an off-island job opportunity, and client was hired. She is waiting for the departure to Atlanta, GA on February 3, 2020.
- **S3-2 (12/23/19-2/21/20):** A Chuukese single woman without children. She works at Zozo Restaurant, making \$900/mo. and is on GHURA Public Housing Amp 4 Waiting List at #20. She lost all IDs prior to entering GSJ and completed application of the replacement of Passport. GSJ SW proposed options of applying for ESG program as soon as she has all required documents and is able to save \$600 a month.
- **S4 (9/20/19-1/18/20):** A Chamorro woman with a disability and her 21-year old son as her caregiver, became homeless after they were evicted from a Section 8 housing after they failed inspection. Though they have a Section 8 voucher, they have been struggling with finding an accessible unit. They receive SNAP but have no income at



this time. In coordination with a Social worker @GBHWC, GHURA ADA Representative, Summer Town Manager, and GSJ SW, client was able to complete Summer Town application and Liheng Apartment application; however, there was no accessible unit even after GSJ extended their stay 30 more days. Client was hospitalized twice while staying at GSJ, and with the understanding of the difficulties with finding accessible unit, client's stay was extended another time until January 18, 2020. In the meantime, one of Liheng Apartment's accessible units was reserved for this client.

- **S5 (12/18/19-2/16/20):** A Kosrean single mom with her adopted toddler daughter was evicted from her in-law's property. She receives SNAP benefits of \$283 a month and is on the GHURA Public Housing Amp 4 Waiting List at #102. HOH, who has one semester away from graduation from GCC for Associate degree in Education, does not want anyone besides herself to take care of her daughter. GSJ SW proposed of options of employment at a daycare center, applying for ESG program, GHURA Amp 2 and 3, and saving money. The SW made phone calls to nearby daycare centers, and client submitted her resume to ABC Daycare Center, where an opening is available.
- **S6 (9/30-12/29):** A married Chamorro couple with a 6-year old boy has moved in from a park in Dededo. The couple needed a Guam ID for employment. The wife has a court case which requires treatment and needs disability certification in order to get GHURA housing assistance. They plan to get disability certification, apply for GHURA, get employed, and save money. With the assistance from GSJ SW, they completed Family Unification Program application and HOH was hired at Black Construction after the couple got Guam IDs with financial assistance from GHC. HOH also got financial assistance from a non-profit organization for work boots. Wife is focusing on disability certification and treatment. With their achievements, their stay was extended 30 more days; however, they failed to save money as they have planned. They moved out on their exit date without a definite place to stay.

### **ORDOT SHELTER**

Ordot shelter has passed all government requirements and has its Business License /Permit to operate as a homeless shelter.

#### **Placement:**

- A man moved to a house as a live-in-caregiver for an elderly under OPG (case number: 091929).

#### **Emergency Housing (EH):**

- Twenty-one (21) men were housed overnight and moved out the next day because there were no 60-day rooms available.

#### **Walk In Assistance:**

- A former Russian client requested for shower service 5 times.
- A former Chuukese client requested for shower service 6 times.
- A former Caucasian client requested for shower service once.
- A Chamorro male requested for shower service once.
- A Caucasian male requested for shower and use of toilet facility once.
- A Chamorro male requested for shower and use of toilet facility once.

#### **Voluntary Exit:**

- A Latino male voluntarily exited early and chose to sleep in his car. (case number:

091930).

**Eviction:**

- None for this reporting period.

**Work Assistance:**

- A Chamorro male received assistance from GSJ SW with a job opportunity as a live-in-caregiver for an elderly from OPG. (case number: 091929).
- A Chamorro male got a financial assistance from GHC for making a REAL Guam ID. He was also assisted by GSJ SW and SM with an off-island job application (case number: 112010).

**Client's Current Status:**

- **R1-1 (11/15/19-1/14/20):** A former Palauan client has moved back to shelter. He is working at New Beginnings as a Peer Specialist and makes \$600/m. He is also on the training for another job @ Drug Court and expects becoming a Certified Peer Specialist after a test in March 2020. He completed GHURA application as a disabled man. He has no utility arrears and is on SNAP. Being employed, he plans to save money, apply ESG program, and rent out as a roommate or with ESG assistance. Out of his first paycheck, client purchased a phone and made a savings of \$200 so far.
- **R1-2 (12/10/19-2/8/20):** A former Caucasian client came back. He receives \$1251/m from SSA and has a broken car. Obligated with GPA arrears, behind rent, and huge hospital bill, client plans to fix his car first, clear GPA arrears, apply ESG program, getting employment through CESEP, file bankruptcy, and save money. With the first SSA, client spent \$750 for deposit for fixing his car and did not make any savings. He submitted CESEP application at American Job Center and is working on Medicare application.
- **R2 (12/23/19-2/21/20):** A Filipino male from DOC with CSC history. He was on RSAT program for 6 month while at DOC and was obligated with getting treatment at New Beginnings another 6 months after discharged. Now volunteering at the New Beginnings, client aims to become a Peer Specialist. He also plans to renew Guam ID and take steps to get a Driver's License, which was expired more than 3 years ago.
- **R3-1 (11/17/19-1/16/20):** A former client of Chamorro decent. Due to his CSC history, he is not eligible for GHURA, ESG, and CESEP. He was a live-in-caregiver at one point and is not interested in that position anymore. He plans to apply for SSDI after he acquires disability certification and is on the way of apply for jobs through AmeriCorps. GSJ SW and SM assisted him with financial assistance from GHC for making REAL Guam ID and with off-island job application.
- **R3-2 (12/12/19-2/10/20):** A Palauan military man with disability is suffering from PTSD. He receives Military disability benefit of \$1400 a month and has completed housing application through WestCare. He is obligated with court fee of \$150/m and a financial assistance of \$300 for his ex-wife and children, who are in another agency. GSJ SW proposed him options of saving \$600 a month, acquire part-time employment, and continue following up with housing application at WestCare. . He applied at the Guam Office of Veterans Affairs for volunteer work.

1. Fire Alarm System needs repair, till then, GSJ conducts GFD fire watch. The repair is

the Landlord's responsibility.

3. Purchase Three (3) Computers, Two (2) for Ordot and one (1) for Dededo Shelter Manager, computers at Ordot shelter; I.T. reports that units are beyond repair.
4. Need Citrus candles and electric fly traps for dinners in the lanai.
5. Need paint for inside and outside of the main shelter and units.
6. Need to repair water blaster.
7. Need 7 each liquid hand soap dispensers for each restroom. For good hygiene.
8. Need 7 each electric air hand dryer for each restroom. For good hygiene.
9. Need to replace all cyclone fence.
10. Need to repair all broken window screens.
11. Need (2) two more security cameras.
12. Need all beds replaced.

### **SERVICE PROVIDED:**

Transportation services were provided to and from both shelters; to job sites, job searches, job interviews, Catholic Social Service Office, home searches, workshops, sponsored dinners, The Salvation Army, Mayor's Offices, Superior Court, Public Health-Dededo, Public Health- Mangilao, SDA Clinic, GBHWC, AHRD, DOL, DOE, GHURA, super markets, etc.

Follow ups were made with The Salvation Army regarding applications for housing assistance. Follow ups were also made on applications that were submitted to various employers for employment via phone calls and transporting clients to and from the work sites.

- Total number of calls that the clients made from the office telephones was 1060.
- Total number of meals that were provided to clients from the food bank was 1015. Eighteen (18) cases or 46 individuals do not qualify for SNAP, and thirty-one (31) case or 83 individuals do not have any income. Meal services also were provided for some clients who were out of food stamp. GJS provided them with food from daily food donations and donated can goods.
- Total number of transportation that were provided to clients was 630 (excluding sponsored dinners).

### **EXPANSION UNITS**

#### **UNIT #1:**

EX 091901: A Chuukese common-law couple with 6 minor children was transferred from Guma San Jose Main Shelter on September 29, 2019. They completed applying all needed documents, including SS card, I-765, passport, and birth certificates. With the complete documents and IDs, they were able to apply for SNAP and Medicaid for their baby and Family Unification Program (FUP) application. All this achieved due to coordination with Micronesia Resource Center and GSJ SW. Client found a two-bedroom extension house at \$750 of rent including utilities and moved out from GSJ with own saving on December 12, 2019.

EX121901: A Chuukese common-law couple with three (3) minor children was transitioned from Guma San Jose Main Shelter on December 19, 2019. HOH is working at Sodexo and IHOP and makes \$1500 a month. They were originally carrying a heavy debt load when they entered GSJ, but have since cleared up their car payment and personal debt and almost cleared GWA arrears of \$659. They are still obligated with trash arrears of \$960. They have received a Section 8 voucher, which will expire on January 14, 2020. Though they found a house, it needs renovation before GHURA inspection, which will be conducted after the landlord comes back from vacation on January 7, 2020. They are not eligible for ESG Program, because HOH does not have an I-94.

They receive public assistance (SNAP, Medicaid, and MIP).

Total number of occupants: Five (5). A family of a couple with three children (ages 12, 9, and 3).

Goals (12/19/19-1/18/20):

1. Clear GWA arrears
  2. Start clearing trash bill
  3. Save money for Security Deposit
- Case management and supportive services are being provided by GSJ Social Worker.
  - Clients have their own transportation.
  - GSJ provides access to the GSJ washing machines/driers.

## **UNIT #2**

A Russian asylum seeking couple with a toddler daughter was transitioned from Guma San Jose Main Shelter on July 5, 2019. HOH is working at Fiesta Resort as a House Keeper, but her husband has been unable to find a job and has been taking care of the daughter while the mother is at work. Though it was approved, they cancelled their ESG application because they expect to receive a letter from USCIS for their Advance Parole application, which would be granted sometime between September and November. They plan to go to South Korea to get medical consultation for husband's hearing problem, and then move to the States. They have been saving money for the upcoming events, and their savings was increased to \$3855. Their Advance Parole case was forwarded from CA to Guam Field Office, where their case was stalled. Client contacted with USCIS at CA, where a worker informed that clients' case would be determined in January 2020, because Guam cases take longer. GSJ SW proposed to them an option of finding a temporary housing and they moved out on December 19, 2019 to an apartment in Tumon with their own savings.

**UNIT #7: Vacant.** GSJ utilizes this unit only for EH.

## **UNIT #8**

EX081901: A Russian couple with a toddler son and an infant daughter was transitioned from Guma San Jose Main Shelter on August 5, 2019. As an asylum seeker, HOH was able to gain employment at Asonoma construction Co; however, they are not eligible for Salvation Army's ESG Program, because the wife and son do not have U.S. Immigration issued work permits and no Social Security cards. Burdened with car payment of \$250/payday and medical bill of \$250/payday, they were also struggling with major engine problem of their car for a long time, and yet they were able to save up \$4099. HOH also acquires Company's Certification for Tower Crane Operator. After a long search for an affordable rental unit, they have moved in a one-bedroom apartment with own savings on December 15, 2019.

EX121902: A Chuukese common-law couple with five (5) children has transitioned from Guma San Jose Main Shelter on December 22, 2019. The husband is working at 7-Day Supermarket and has an income of \$780 a payday. They were obligated with utility arrears, loan payment of \$1000, and personal debt of \$400. They receive SNAP of \$944 a month. GSJ SW proposed them options of clearing utility arrears, opening a bank account, save \$300 a payday, and apply for GHURA housing and ESG Program. After completing Family Unification Program application with assistance from GSJ SW, they cleared out arrears and debt out of their savings, and purchased a used car with a tax return of \$7000+. Though they have completed ESG Program application, they decided to find an affordable house with own savings of more than \$6000. Considering their

savings amount, GSJ managers and SW proposed them an option of finding a place and moving out by January 21, 2020. They found a three-bedroom house in Dededo and plan to move in after cleaning it.

#### **UNIT #9**

Chuukese common-law couple with two (2) toddlers was transitioned from Guma San Jose Main Shelter on August 29, 2019. Husband is working at Asonoma Construction Co and receives a paycheck of \$1500 a month. Their financial obligations include utility arrears, court payments, and petty cash support for the husband's mother in Chuuk. They also receive \$300 from SNAP. After clearing utility arrears, they applied for Salvation Army's ESG Program, but they decided to find an affordable house/unit with their own savings because they were not able to find a unit within the due date. While looking for a rental house, they cleared remaining court fee of \$390 and purchased a used car with \$1500 plus \$550 for fixing it out of their savings. They also completed FUP application with GSJ SW's assistance.

They receive public assistance (SNAP, Medicaid, and MIP).

Total number of occupants: Four (4). A family of a couple with two toddlers (ages 1 year and 11 months).

Goals (11/27/19-1/10/20):

1. Move in to the extension house by January 10, 2020.
- Case management and supportive services are being provided by GSJ Social Worker.
  - Clients have their own transportation.
  - GSJ provides access to the GSJ washing machines/driers.

Status Update: They found an extension house with the rent of \$650/m and paid Security Deposit of \$650 to the landlord and. Their current savings is \$504 and they expect to receive \$900+ on January 5, 2020, when they start moving out from GSJ.

#### **Eviction:**

- None for this reporting period.

#### **Transition Progress:**

- A family of four (4) moved out to an apartment on November 25, 2019 with assistance from ESG (case number: EX 061901).
- A family of eight (8) moved out to an extension house on December 12, 2019 with own savings (EX091901).
- A family of four (4) moved out to an apartment on December 15, 2019 with own savings (case number: EX 081901).
- A family of three (3) moved out to an apartment on December 19, 2019 with own savings (case number: EX071901).

#### **OUTREACH**

- October 3, 2019 – Chamorro male, approximately 50 yrs. old, living in abandoned house in Barrigada Village. Unemployed with a bad case of gout. Visited to find out if GSJ could be of service. Found out that he was a client at the Men's shelter earlier last year. His stay was cut short because he needed to be hospitalized at GMH

because of a gout attack. He never returned to GSJ after GMH. He was informed how he could benefit from our services and reconnect him with Government services. He showed interest in coming back to apply for a sixty day stay. Left him with food and contact numbers and connected with his aunt who visits him regularly. A follow up was conducted the week leading up to UST Medical Outreach in order to invite him. He was not at the abandoned house, according to his aunt, he was at GMH because of his gout. Will follow up next month.

- October 29, 2019- Young Chamorro couple staying under pavilions at Chamorro Village. Male 27, Female 22, both unemployed, female is pregnant. The previously signed up on GSJ wait list but changed their mind and prefer staying in Agana. They were given brochure and food and reminded they were welcome to stay at GSJ.
- November 17, 2019 –World Day of Poor Outreach, Present were M. Suzuki, PJ Santa Maria, J. Agoun. Passed out 21 bags. One Emergency Housing turned out to be a 60-day stay.
- December 18, 2019 one male 34 years old African American Veteran, needed food, hygiene products, and household utensils (pots, pans, plates). M.S.
- December 24, 2019 outreach referred by Barsen. M.S.
