

Speaker Barnes:

Thank you for your letter regarding the Tier 2 clinics earlier this month. Based on the tone of that letter, I am concerned that my conversations with the Majority on May 3rd, may have been misunderstood. While the largest portion of the meeting was based on my plans for Executive Orders 2020-12 and 2020-13, the conversation did turn to my use of emergency purchases for the various vendors that we needed to acquire during the early days of this emergency. And in that conversation, you asked that I use that authority to immediately pay some vendors and the Tier 2 clinics.

I worry that the meeting may have ended with miscommunication. I am concerned that your letter unintentionally casts an untrue perception of these Tier 2 clinics, among other clinics, who have worked selflessly and at their own expense for the betterment of the health of our people on the island. Like so many of the medical professionals on Guam, Tier 2 clinics has done this without any arrangement with the government of Guam. We were quite clear on that.

As I have shown in my first iteration of the CARES Act Funds budget, I am developing a program to encourage all medical clinics to help Guam keep, not only the potential of a second and more lethal surge of COVID-19 at bay, but also to sustain a program of preventative and maintenance health care. This is to ensure that our hospitals remain ready and able to care for all illnesses and ailments needing hospitalization. COVID-19, as horrible as it has been, has shown us that there is hope that all medical facilities, both public and private, can work together to keep our island

Hafa Adail We hope this letter finds you well. As we look back at the original projections and our cases today – I want to take the time to thank you and your team for a job well done. While we agree with you that we are not in the clear just yet, we are all optimistic that should we stay the course, we will prevail. It is with that same logic that we write to you regarding the status of our Tier Two clinics. I have heard from all three Tier Two clinics that have been designated by the C.U.R.E. Task Force who have stated that they have yet to receive any payment for the services that have been provided to our community.

Pursuant to Executive Order 2020-06, relative to creating the CURE Action team and the policies to combat this Pandemic, one of the provisions allows for the CURE Action team to direct Health Care Clinics to provide necessary health care services. It also states that participating clinics shall be reimbursed for services provided as agreed upon through a Memorandum of Understanding (MOU) to be developed by the CURE Action Team.

As noted in JIC Release No. 30, dated March 24th, 2020, American Medical Center, FHP Health Care Center, as well as the Seventh-Day Adventist Clinic have been deemed as "Tier-Two" facilities to provide Urgent Care to residents. From our follow-ups today with all three of these clinics, they have yet to receive a single cent, as the Government of Guam has yet to adopt an MOU as required by E.O. 2020-06.

We have also been informed that they have presented an MOU and is awaiting action from your end. They have also expressed to us, that there seems to be a lack of understanding between the clinics and the Governor's office on the impact that becoming a Tier-Two clinic has on a Health Care facility. As such, I have been requested to facilitate a tour of a tier-two clinic to get a firsthand understanding of their operations. While my staff and I have been tested at these clinics, and we have observed and experienced it firsthand, should you feel that
