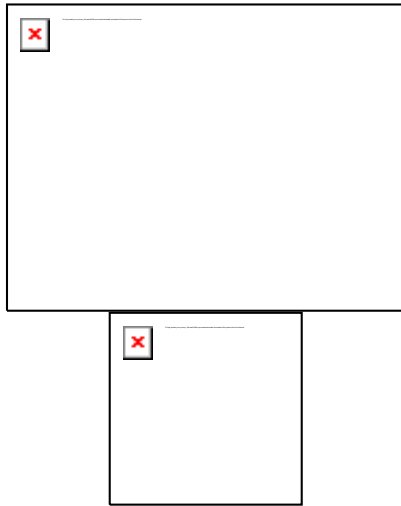

Proclamation No. 2020 – 21

PROCLAIMING

in Accordance with Guam Law the

***SECOND POSTPONEMENT OF SPECIAL
ELECTION FOR THE OFFICE
OF THE MAYOR OF YOÑA***

WHEREAS, pursuant to Section 40104 of Chapter 40, Title 5 Guam Code Annotated, the term of Mayors and Vice Mayors is for a period of four (4) years, with the current term having begun on January 2, 2017, and ending January 4, 2021; and

WHEREAS, pursuant to Section 13106 of Chapter 13, Title 3 Guam Code Annotated, the municipal office of Mayor becomes vacant upon the resignation of a mayor; and

WHEREAS, on January 30, 2020, Yoña Mayor Jesse M. Blas announced his resignation; and

WHEREAS, pursuant to Section 13107 of Chapter 13, Title 3 Guam Code Annotated, the Guam Election *shall* call for a special election on a Saturday on or about sixty (60) days after a vacancy occurs in an office of Mayor; and

WHEREAS, pursuant to Section 5105 of Chapter 3, Title 3 Guam Code Annotated, at least thirty (30) days before any special election, *I Maga'hågan Guåhan* shall publish an election proclamation, and transmit copies to the Guam Election Commission; and

NOW THEREFORE, I, LOURDES A. LEON GUERRERO, *I Maga'hågan Guåhan*, Governor of Guam, by virtue of the authority vested in me by the Organic Act of Guam, as amended, do hereby proclaim that the Guam Election Commission *shall* conduct a **Special Election** for the purpose of filling the vacancy left in the Office of the Yoña Mayor, said Special Election which shall be held on Saturday, May 30, 2020, from 7:00 a.m. to 8:00 p.m., except as provided in 3 G.C.A. Section 9143.
