AN ACT TO APPROPRIATE THE SUM OF ONE HUNDRED TWENTY THOUSAND DOLLARS (\$120,000.00) FROM THE GENERAL FUND FOR THE PROGRAM AT THE HEALING HEARTS OF MENTAL HEALTH AND DEPARTMENT SUBSTANCE ABUSE, RELATIVE TO INSURING AND STRENGTHENING THE EFFECTIVENESS OF THE PROGRAM FOR REMAINING FISCAL YEAR 1998.

## **BE IT ENACTED BY THE PEOPLE OF GUAM:**

1

Section 1. Legislative Findings. I Liheslaturan Guahan finds that, while 2 the Fiscal Year Budgets for 1998 and 1999 for the Department of Mental Health 3 and Substance Abuse has been approved pursuant to the budget digest 4 5 submitted by the Department of Mental Health and Substance Abuse, the administration and management of the Healing Hearts Program requires 6 7 additional funds to make the Healing Hearts more effective in assisting victims of violent sexual acts and providing them with a suitable venue where they may 8 9 be counseled, examined and interviewed.

Further, when the Healing Hearts Program was first set up, its mission was to provide crisis counseling, physical examination and other services needed by victims of violent sexual acts. A significant amount of training was performed to make the Healing Hearts Program work.

Section 2. Appropriation. One Hundred Twenty Thousand Dollars
(\$120,000.00) is appropriated from the General Fund to the Department of Mental
Health and Substance Abuse for the Healing Hearts Program for the remaining
part of Fiscal Year 1998 until completely spent.

## **PUBLIC NOTICE:**

Pursuant to the requirements of Public Law 24-139, notice of the public hearing on Bill No. 540 (COR) was published in the Pacific Daily News on March 20, and March 24, 1998.

#### **PUBLIC HEARING:**

The Committee on Finance and Taxation conducted a public hearing on March 25, 1998 at 9:00 AM in the I Liheslåturan Guåhan Public Hearing Room to hear testimonies on Bill No. 540 (COR).

#### **COMMITTEE MEMBERS PRESENT:**

The hearing was called to order by the Chairman of the Committee on Finance and Taxation, Vice Speaker Anthony C. Blaz. The following Committee members were present:

## **PROVIDING TESTIMONY:**

Mr. John W. Leon Guerrero, Acting Director, Department of Mental Health and Substance Abuse Alicia Limptiaco, Assistant AG, Department of Law, Prosecution Division Lenny Rapadas, Chief Prosecutor, Department of Law, Prosecution Division

## **BACKGROUND:**

Mr. John W. Leon Guerrero, Acting Director, Department of Mental Health and Substance Abuse, informed the Committee that he was not aware of Bill No. 540 (COR) and requested two weeks to prepare additional testimony. He wanted to outline what his department has accomplished in the last four months dealing with the problems they faced administering the Healing Hearts Program. In addition, he specifically wanted to describe the critical components of the Rape Crisis Center and how his department is addressing each component. The Chairman granted additional time.

Alicia Limptiaco, Assistant AG, Department of Law, Prosecution Division, expressed her concern concerning the possible conflict of interest by transferring the Healing Hearts Program to the Superior Court; Healing Hearts should remain with the Department of Mental Health and Substance Abuse and independent of the Judiciary.

### **FINDINGS:**

The Committee finds that:

 Although the administration and management of the Healing Hearts Program by the Department of Mental Health and Substance Abuse needs improvement, it is in the best interest of the victims to keep the Healing Hearts Program independent of the Judiciary so as to prevent possible conflict of interest situations from occurring when issues concerning victims and their perpetrators arise.

The Healing Hearts Program requires an additional appropriation of one hundred twenty thousand dollars (\$120,000) from the General Fund to the Department of Mental Health and Substance Abuse to fund the remaining part of the Program's operations for Fiscal Year 1998.

#### **COMMITTEE RECOMMENDATIONS:**

The Committee, having conducted a sufficient hearing, does hereby recommend to the I Liheslåturan Guåhan to do pass substitute Bill No. 540 (COR) AN ACT TO APPROPRIATE THE SUM OF ONE HUNDRED TWENTY THOUSAND DOLLARS (\$120,000) FROM THE GENERAL FUND FOR THE HEALING HEARTS PROGRAM AT THE DEPARTMENT OF MENTAL HEALTH AND SUBSTANCE ABUSE RELATIVE TO INSURING AND STRENGTHENING THE EFFECTIVENESS OF THE PROGRAM FOR REMAINING FISCAL YEAR 1998.
