AN ACT TO AUTHORIZE THE MILITARY ORDER OF THE PURPLE HEART, GUAM CHAPTER 1315, TO USE A PORTION OF THE SKINNER PLAZA TO ESTABLISH A MEMORIAL MONUMENT TO HONOR ALL WOUNDED COMBAT SOLDIERS, BY *ADDING* A NEW §79601.1 TO TITLE 21, GUAM CODE ANNOTATED.

BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan
- 3 finds that the Military Order of the Purple Heart, Guam Chapter 1315,
- 4 wishes to use a portion of the Skinner Plaza to establish a memorial
- 5 monument, honoring all Purple Heart recipients, particularly those who

1 made the ultimate sacrifice in service of our country to protect our freedom

2 and liberty. The Purple Heart is a military decoration bestowed to any

3 member of the United States Armed Forces who, while serving with the

4 United States Armed Services, has been wounded or killed in action. The

5 Military Order of the Purple Heart is the only combat organization

6 chartered by the United States Congress.

I Liheslaturan Guåhan further finds that the Skinner Plaza is located within the Guam Capitol District, and pursuant to 21 GCA §79601, the Guam Capitol District is within the Guam Legislature's control and supervision.

It is therefore the intent of *I Liheslaturan Guåhan* to grant the Military Order of the Purple Heart, Guam Chapter 1315, the authority to erect a monument within the Skinner Plaza.

Section 2. A new §79601.1 is hereby *added* to Article 6 of Chapter 79 of Subpart E of Title 21, Guam Code Annotated, to read as follows:

"§79601.1. The Military Order of the Purple Heart, Guam Chapter 1315, is hereby authorized to erect a memorial monument in the Skinner Plaza, next to the monument of General Douglas MacArthur, in honor of the service and sacrifices of the Purple Heart recipients; provided the Military Order of the Purple Heart, Guam Chapter 1315, (a) does not occupy more than twenty feet (20') in length and twenty feet (20') in width of the Skinner Plaza; (b) submits to *I Liheslaturan Guåhan* the plan and design of the monument for legislative approval by statute or resolution; and (c) does not hold the Government of Guam liable or responsible for any

expenses related to the construction or maintenance of the monument authorized herein."

Section 3. Severability. *If* any provision of this Act or its application to any person or circumstances is found to be invalid or contrary to law, such invalidity shall *not* affect other provisions or applications of this Act which can be given effect without the invalid provisions or applications, and to this end the provisions of this Act are severable.

Committee Report

Bill No. 324 (COR) As Amended by the Author and substituted by the Committee on Community, Culture, Recreation and Public Broadcasting, "AN ACT TO AUTHORIZE THE MILITARY ORDER OF THE PURPPLE HEART, GUAM CHAPTER 1315 TO USE A PORTION OF THE SKINNER PLAZA TO ESTABLISH A MEMORIAL MONUMENT TO HONOR ALL WOUNDED COMBAT SOLIDERS."

Introduced on June 18, 2004

Public Hearing conducted on September 9, 2004

I. INTRODUCTION

Bill No. 324 (COR) "AN ACT TO AUTHORIZE THE MILITARY ORDER OF THE PURPPLE HEART, GUAM CHAPTER 1315 TO USE A PORTION OF THE SKINNER PLAZA TO ESTABLISH A MEMORIAL MONUMENT TO HONOR ALL WOUNDED COMBAT SOLIDERS" was introduced by Speaker v.c. pangelinan with Senator R.J. Respicio as a co-sponsor.

II. PUBLIC HEARING

The Committee on Community, Culture, Recreation, and Public Broadcasting (CCRP) conducted a public hearing beginning at 10:00 a.m. on Thursday, September 9, 2004 on Bill 324 (COR) in the Legislative Public Hearing Room, *I Liheslaturan Guahan*, in Hagåtña. Public notice was provided September 2nd and 7th, 2004.

CCRP Committee Chair Senator Tina Rose Muña Barnes called the public hearing to order. Vice Chair Senator Rory J. Respicio, Speaker v.c. pangelinan, Senator Robert Klitzkie and Senator John M. Quinata were also present.

Those who signed up to give oral testimony were Mr. Juan Cepeda, Mr. Francisco Lizama, Mr. Frank Artero and Mr. Benjamin Garrido.

III. TESTIMONY

CCRP Chairperson Senator Muña Barnes began by yielding to Vice Chair Senator R.J. Respicio, who said the bill was introduced as per request by Guam Chapter 1315 to erect a monument that reflected Guam's appreciation of the fine men and women who have put their lives on the

line for the freedoms we enjoy today. He said this bill will gain the full support of this Committee.

Senator Muña Barnes then called Mr. Juan Cepeda, Mr. Francisco Lizama, Mr. Ben Garrido and Mr. Frank Artero to the witness table to testify.

Mr. Juan Cepeda, U.S. Army veteran, was first to testify. He read his written testimony that fully supported Bill 324 (COR). He said that although America has no King or Queen, it does have nobility and that nobility are its veterans who have put Guam on the map and exhibited loyalty, courage and integrity. He said that he was awarded a Purple Heart medal and that he wears it with pride. He noted that the medal symbolizes patriotism in defense of a great nation and demonstrates to our youth that freedom comes with sacrifice and blood and is not free.

Mr. Lizama next read aloud the written statement of Mr. Jack Shimizu, Commander. Mr. Shimizu's testimony points to the uniqueness of the Military Order of the Purple Heart as being the only combat organization chartered by Congress. It stated that the single bond that unites its members is that each has sustained a wound inflicted by an enemy in combat. It noted that the proposed memorial would perpetuate the heroic service of our combat wounded veterans and active military. Mr. Shimizu wrote that such a memorial would pay tribute to all the past and present freedom fighters who have been willing to sacrifice themselves to ensure our freedom and liberty.

Mr. Frank Artero testified next in support of Bill 324 (COR). He read his written testimony that stated that although the veterans don't consider themselves heroes, they are humbled and honored by this recognition. Mr. Artero spoke of the all the nameless young men and women who have

gone before us as servants of valor and defenders of freedom. He said this memorial honors all of them and is fully supported because of that.

Mr. Ben Garrido, who received a Purple Heart for wounds he received in the Vietnam War, testified next. He joined Mr. Cepeda in thanking Senator Respicio for his thoughtful comments on the importance on Bill 324. Mr. Garrido said Guam veterans often remind each other that Guam soldiers receive the most wounds per capita than any other place in America. He noted that while in Washington D.C. in March of that year, he was moved that Guam was so duly recognized in the nation's capital. He said that all the veterans ask is that a small portion be reserved for a memorial in honor of those wounded in combat. He noted that it is common knowledge that people from Guam consistently prove to be the most patriotic and loyal Americans. He said the headquarters of the Military Order of the Purple Heart in Virginia immediately offered the veterans of Guam a monument when they requested one. He closed by thanking his fellow veterans for their presence.

CCRP Chairperson Senator Muña Barnes then welcomed Speaker v.c. pangelinan for his attendance and yielded to him as the Author of Bill 324 (COR). He spoke briefly to say that the bill is simple and merely accords honor to the men and women of our Armed Forces who deserve such a tribute for giving a portion of their lives to our freedom.

Senator Muña Barnes yielded next to Senator Klitzkie who asked about what the monument would look like. Mr. Lizama responded by describing it as being uniform to other Purple Heart monuments erected throughout the U.S.

Senator Muña Barnes then yielded to Senator Quinata who said he was in full support of Bill 324 (COR) which honors all our veterans and that he looks forward to seeing the monument erected.

Senator Muña Barnes yielded to Senator Respicio who thanked Speaker Pangelinan for authoring the bill and noted that the Committee only had one amendment to Bill 324 (COR), to add the phrase "The Military Order of the Purple Heart is the only combat organization chartered by Congress" to Section 1.

Senator Muña Barnes closed by thanking the veterans for all they have done to protect the freedoms we enjoy today, and said that she hoped to have this report done expeditiously. There being no further testimony from the attendees and Senators, Senator Muña Barnes declared Bill No. 324 (COR) to have been publicly heard.

Additional written testimony was submitted at the close of the public hearing by Mr. Thomas Morrison, Director of the Department of Parks, Recreation. Mr. Morrison wrote that the department was in support of Bill 324 (COR) and declared that Skinner Plaza would be an appropriate area to place the memorial monument to honor all wounded combat soldiers as other memorial monuments commemorating various war eras are placed there.

IV. FINDINGS AND RECOMMENDATIONS

The Committee on Community, Culture, Recreation and Public Broadcasting finds that the following proposed amendment to Bill No. 324 (COR) is just and valid and should be included in a substitute version of the bill:

1. Added to Section 1, line 10 shall be the sentence: The Military Order of the Purple Heart is the only combat organization chartered by Congress."

The Committee on Community, Culture, Recreation and Public Broadcasting hereby reports out Bill No. 324 (COR), as amended, with the recommendation to do pass.

Madam Chairwonan, Members of the Committee on Community, Culture, Recreation and Public Broad Casting.

On behalf of the Patriots of the Military Order of the Purple Heart Guam Chapter 1315, I would like to thank you for holding this public hearing on Bill 324, and a personal thank you to the author of Bill 324.

Although section 1 of Bill 324 spell out the findings and intent. I would also like to impart on this committee that the Military Order of the Purple Heart is the only combat organization that is chartered by Congress. There is a proud history to an award which was created for gallantry, but also of extraordinary fidelity. The order to establish the first Purple Heart was issued by General George Washington during the Revolutionary War. The official papers that were signed by General Washington was saved from burning during the war of 1812. The famous award was revived in 1932 by President Hoover and General Douglas MacArthur. Today, as in the past, the single bond that unites members of the order is that each has sustained a wound inflicted by an enemy in combat. There is no exclusion by war or branch of service. The member's common bond is that they have given of their own blood.

Military Order of the Purple Heart (MOPH)

It is definitely a combat decoration.

The Order of the Purple Heart is awarded to members of the armed forces or Coast Guard of the U.S. who are wounded by an instrument of war in the hands of an enemy and posthumously to the next of kin in the name of those who are killed in action or die of wounds received in action.

Intrinsically, the Purple Heart is the world's costliest decoration--nineteen separate operations are required to make it from the rough
heart stamped from bronze to the finished medal plated with gold and
enameled in various colors, suspended from a purple and white ribbon

Exclusively for Combat Wounded Veterans. The Veterans awarded the
Purple Heart are proud to be members of the Military Order of the Purple
Heart. This group of patriots serves as a reminder to our nation and to the
world that we have shed blood for our country, as we fight to defend our
freedom. The Order deserves the full support of all those who are eligible for
membership." Membership in the Military Order of the Purple Heart is
limited by public law to "...persons who have received the Purple Heart
during combat..." There is a proud history to this award which was created
for "gallantry but also of extraordinary fidelity and essential service."
Composed exclusively of Purple Heart recipients, it is the only veteran's
service organization comprised strictly of "combat" veterans.

The order to establish the first Purple Heart was issued by George Washington during the Revolutionary War. The official papers, signed by Washington, were saved from burning during the War of 1812. The famous award was revived in 1932 by President Hoover and General Douglas Macarthur. The revived form is in metal, instead of perishable cloth, made in the shape of a rich purple heart bordered with gold, with a bust of Washington in the center and the Washington coat-of-arms at the top. The latter is believed to have been the source of the stars and stripes of the American Flag.

Today, as in the past, the single bond that unites members of the Order is that each has sustained a wound inflicted by an enemy in combat. There is no exclusion by war or branch of service.

The Purple Heart" is an American decoration; the oldest military decoration in the world in present use and the first award made available to a common enlisted, not officer, soldier. It was created by one of the world's most famed and best loved heroes - General George Washington.

(The Preamble to the Constitution of the Military Order of the Purple Heart)

We, combat veterans of the wars of the United States and recipients of the Purple Heart medal, awarded by the United States Government and founded by General George Washington on August 7, 1782, at a critical time in our history, drawn together by bonds of respect and mutual suffering, have established the Military Order of the Purple Heart, chartered by the Congress of the United States, in order to perpetuate the principles of patriotic allegiance to the United States of America, fidelity to its Constitution and laws, the security of civil liberty, and the permanence of free institutions.

Through this organization and our membership in it, we hope to be able to preserve and perpetuate those ideals of liberty, justice and the general welfare which are the very foundations of our way of life. We further pledge to foster and enhance those principles which, from the beginning of our national history, have served as a beacon of hope and salvation to the peoples of all nations.

The members of the Military Order of the Purple Heart are patriots. By Patriotism we mean true allegiance to the government of the United States of America and fidelity to its Constitution and laws. Patriotism is devotion to our Country which demands that we do our utmost to make our home, our city, our state and our nation a better place in which to live. In time of emergency we must give all we have of loyalty, service, savings and sacrifice in defense of our Country and our Flag.

We often tell each other that we have the most killed per capita and the most wounded in action. It is estimated that there were over 600 members of the

armed forces wounded during the Vietnam conflict. Still many were wounded during World War II and Korea and several during the gulf war. We are at war today and Americans are shedding their blood around the globe so we can continue to enjoy the so desired freedom. The chapter has 44 members and growing and we meet on the 3rd

Thursday of each month at 6:00 P.M. (1800) at the conference room of the Office of Veterans Affairs in Tiyan. We have diverse membership from the three services of Army, Navy and Marines. Our membership is open to all branches of the service and all Wars or conflicts with the enemy. If you were awarded the Purple Heart and residing in Guam, request that we notify the National headquarters and assign you to Chapter 1315. If you don't belong to



the Order or have questions concerning the Chapter and would like to join us please call the Chapter Commander at 632-1101. We have plenty of applications on hand. We are recruiting wives and daughters for the ladies auxiliary. As liberators and visitors returning to Guam will express "there is not a single place that is more patriotic than Guam." Paradise is all we ask for to honor the many that gave all and the hundreds that bleed in the battle fields protecting our freedom.
