I. OVERVIEW

The Committee on General and Omnibus Matters held a public hearing at 9:00 a.m. on March 8, 2006 in the Session Hall, I Liheslaturan Guåhan. Public notice was given to all media (see facsimile confirmation page) on March 1 and March 6, 2006. Notice was placed in the PDN on March 6, 2006.

II. SUMMARY OF TESTIMONY

Individuals that appeared before the Committee to present oral and written testimony on the bill were as follows:

Mr. Michael Flaherty, provided oral testimony in support of Bill No. 227. Mr. Flaherty stated that he is the owner of property in the vicinity of the fractional lots in question and is in partnership with owners of adjacent property and would like to acquire the lots in order to construct an office building on the consolidated site.

For Reference Only

The subject of Bill No.227(EC) is related to a previous issue before the Legislature. Bill No.149, now Public Law 28-83, allowed for the sale of a fractional lot owned by GovGuam to Mr. Flaherty. As the deliberation on Bill No. 149 is apropos to Bill No. 227, the committee report is appended hereto for reference.

III. FINDINGS AND RECOMMENDATION

The Committee on General and Omnibus Matters finds that the subject fractional lots were acquired by the government of Guam through the exercise of its option to take possession of them for non-payment of taxes. The Committee also finds that these lots are too small to be of any economic value to GovGuam in and of themselves and that the sale of the lots would enable new economic activity which would enhance Guam's property and income tax base.


