BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan finds

the Nursing Department includes biomedical equipment that is portable, modular

It is the intent of *I Liheslaturan Guåhan* to appropriate Thirty Thousand Dollars (\$30,000.00) to the Guam Memorial Hospital for the *sole* purpose of purchasing equipment and supplies for the Nursing Department.

Section 2. De-appropriation and Reappropriation. The sum of Thirty 8 9 Thousand Dollars (\$30,000.00) is hereby de-appropriated from the sums appropriated to I Liheslaturan Guåhan for Fiscal Year 2006 and reappropriated to 10 the Guam Memorial Hospital for the sole purpose of purchasing supplies and 11 equipment for the Nursing Department, specifically, Welch Allyn AD-9009 12 Monitor with NIBP, Nelcor Pulse Oximetry and Temperature Mobile Stand with 13 its accompanying monitor stand and accessory basket. Notwithstanding any other 14 law or rule, the Fiscal Officer of I Liheslaturan Guåhan shall reduce the budget 15 allotment to Senator Lou Leon Guerrero for Fiscal Year 2006 by an amount equal 16 to the sum de-appropriated by this Section and transfer that sum to the Department 17 of Administration for expenditure in accordance herewith. 18

Section 3. Reporting. Within sixty (60) days after the end of Fiscal Year 2006, the Guam Memorial Hospital shall submit a written report regarding the expenditure of this appropriation to *I Liheslaturan Guåhan*. No portion of this appropriation shall be used for purposes other than that specifically defined in Section 2 of this Act.

The types of equipment that is currently lacking in the Nursing Department include biomedical equipment that is portable, modular vital signs machines that measures patients' blood pressures, pulse/heart rate, body temperatures and oxygenation levels. Replacement of old equipment and/or adding new equipment to their current inventory can only lead to accurate and reliable medical care. With the shortage of nurses, it is imperative that we provide the nursing staff the necessary tools to ease their workload thereby decreasing fatigue and stress.

It is the intent of the *I Liheslaturan Guahan* to deappropriate thirty thousand dollars (\$30,000.00) to the Guam Memorial Hospital for the sole purpose of purchasing equipment and supplies for the Nursing Department.

Section 2. Deappropriation and Reappropriation. The sum of Thirty
Thousand Dollars (\$30,000.00) is hereby deappropriated from the sums appropriated to

COMMITTEE REPORT ON BILL NO. 265 (EC)

AN ACT TO DEAPPROPRIATE THIRTY THOUSAND DOLLARS (\$30,000.00) FROM THE SUMS APPROPRIATED TO THE I LIHESLATURA GUAHAN FOR FISCAL YEAR 2006 AND TO REAPPROPRIATE SAID SUM TO THE GUAM MEMORIAL HOSPITAL FOR THE SOLE PURPOSE OF PURCHASING SUPPLIES AND EQUIPMENT FOR THE NURSING DEPARTMENT.

I. OVERVIEW

The Executive Committee held a public hearing at 9:00 a.m. on March 29, 2006 in the Session Hall, I Liheslaturan Guåhan. Public notice was given to all media (see facsimile confirmation page) on March 22 and March 27, 2006.

Senators present at the public hearing were:

Speaker Mark Forbes, Chairman Senator Lou Leon Guerrero

II. SUMMARY OF TESTIMONY

Individuals that appeared before the Committee to present oral and written testimony on the bill were as follows:

Ms. Lillian Posadas, RN,MN, Hospital Nursing Services Administrator, Nursing Department, Guam Memorial Hospital Authority, provided written testimony in support of Bill No. 265. Ms. Posadas wrote "Inasmuch as we attempt to budget and procure the much needed biomedical equipment such as the VitaChecks, the requisitions we submit have either been rejected or denied due to the hospital's limited financial resources. This re-allocation legislation will indubitably allow the hospital to procure the critically needed additional biomedical equipment".

Discussion:

Senator Lou Leon Guerrero, Author of Bill No. 265 (EC) provided brief remarks on her bill. Senator Leon Guerrero said that GMH is currently an acute care facility and recently opended more beds in its telemetry unit. She said this funding will provide the nurses at GMH with the diagnostic tools to make the proper assessments of a patient's condition.

III. FINDINGS AND RECOMMENDATION

The Executive Committee finds that the intent of Bill No. 265 will provide the funding to replace old equipment and or purchase new equipment at the Guam Memorial Hospital. The deappropriated amount of \$30,000 (thirty thousand) dollars from the budget allotment to Senator Lou Leon Guerrero and reappropriated to GMHA will be specifically be used by the GMHA Nursing Department to update its equipment inventory.

Good Morning. Buenas yan Saluda. On behalf of the staff and management of GMHA, I am here to express our sincere appreciation and full support of Bill No. 265. Senator Lou Leon Guerrero's idea of re-allocating funds from her office to the hospital for the purpose of procuring the much needed biomedical equipment such as the VitaCheck machines is indeed a very honorable and generous gesture.

At present, the hospital has, in its inventory of the VitaCheck machines that are fully operational, approximately 20 for the entire 168 acute patient-care units and 30 long-term care beds at SNU. This equates to approximately 1 vitacheck machine for every 10 patients. In addition to these inpatient care beds, we also have the Emergency Room, OR/PAR, Outpatient Hemodialysis and L&D units that have either only 1-2 functional machines to accurately assess and monitor the blood pressure readings, heart rates, body temperatures and oxygenation saturation levels. Inasmuch as we attempt to budget and procure the much needed biomedical equipment such as the VitaChecks, the requisitions we submit have been either rejected or denied due to the hospital's limited financial resources. This re-allocation legislation will indubitably allow the hospital to procure the critically needed additional biomedical equipment.
