I. OVERVIEW

The Committee on General and Omnibus Matters held a public hearing at 9 a.m. on January 20, 2005 in the Public Hearing Room, I Liheslaturan Guåhan. Public notice advertisement was given in the January 13 2005, edition of the Pacific Daily News (PDN), posted in the Government Meetings Section in the January 17, 2005 edition of the PDN, and Public Notice Ad in the January 18, 2005 edition of the Marianas Variety, Guam Issue. A live broadcast of the public hearing appeared on Channel 61 that day (January 20, 2005).

II. SUMMARY OF TESTIMONY

Individuals appearing before the Committee to present oral and written testimony on the bill are as follows:

The Honorable Jose Rivera, Former Mayor of Dededo (Oral testimony) – In Favor The Honorable Scott Duenas, Former Mayor of Dededo (Oral testimony) – In Favor The Honorable Melissa Savares, Mayor of Dededo (Oral testimony) – In Favor Mr. Joey Duenas, Finance Officer, Archdiocese of Agana (Oral & Written testimony) – In Favor

Mr. Jose Rivera, former Mayor of Dededo, offered oral testimony in support of Bill No. 10 and provided the Committee a historical perspective of the Machanao and Perez Garden subdivisions and the reason for the lack of recreational facilities and bus shelters in the area. According to Mr. Rivera, the parcel of land which encompasses the subdivision was subdivided into half-acre agricultural lots. Because of this, there was no legal requirement to set aside land for recreational purposes. Mr. Rivera suggested that this issue is one that the Legislature may wish to revisit given that agricultural subdivisions may become residential areas with no provision for recreation facilities, as is the case with Machanao and Perez Gardens. Mr. Rivera stated that the long-standing problem in the areas finally will be addressed by Bill No. 10 and reiterated his support for the measure.

Mr. Scott Dueñas, former Mayor of Dededo, provided oral testimony in support of Bill No. 10, agreeing with the testimony provided by Mr. Rivera and expounding on the need for bus shelters and recreational facilities in the Machanao, as it is one of the most densely populated areas in Dededo without such facilities. He stated that the passage of Bill No. 10 and the subsequent construction of the needed facilities would be of great benefit not only to the residents of Machanao but the community as a whole.

Melissa Savares, Mayor of Dededo, provided oral testimony in support of Bill No. 10 on behalf of herself and the Dededo Municipal Planning Council. Mayor Savares stated that the Machanao subdivision is in desperate need of recreational facilities and bus shelters. She informed Senators that the Planning Council has approximately \$90,000 that could be used toward the construction of the facilities. The Mayor also indicated the location of land under the Council's jurisdiction that would be exchanged, should the Bill be enacted.

Mr.Joseph T. Dueñas, Finance Officer, Archdiocese of Agana, provided oral and written testimony in support of Bill No. 10. Mr. Dueñas indicated that the Archdiocese of Agana has no immediate plans for the lot it owns as identified in the Bill and supports the efforts of the Dededo Municipal Planning Council to develop recreational facilities in the Machanao area.

Member Questioning and Commentary

Several senators questioned the panel on such matters as facility maintenance, insurance, and FEMA issues.

On the issue of the Bill, **Senator Palacios** expressed his concern over area-for-area exchange provision of the Bill and questioned whether a value-for-value exchange would be more appropriate. **Mr. Joseph Dueñas** responded that the areas in question are contiguous, they share the same basic makeup and that the assessed value for the properties are similar. He stated that an area-for-area exchange in this case would be a win-win situation.

Senator Jesse Lujan expresses his concern that the subject properties should be appropriately zoned. **Mr. Joseph Dueñas** informed the Committee of the federal statute prohibiting any municipality from imposing zoning restrictions on church owned property except as it relates to public health and safety and the protection of the environment.

Vice-Speaker Joanne Brown inquired as to whether the subject properties have been surveyed and if not, suggested that the issue be addressed before final action is taken on the Bill. Mr. Joseph Dueñas responded that the church property has been surveyed and that the government property is part of a larger parcel and has not been surveyed nor has it been subdivided.

Senator Bob Klitzkie asked which of the two parties is the major proponent of the Bill. Mr. Joseph Dueñas responded that the needs of the Archdiocese would be met at either location given their proximity and that the Archdiocese's agreeing to the exchange is to accommodate the Municipality. Senator Klitzkie questioned why, if the subject land is owned by the Dededo Municipal Planning Council by virtue of being deeded by the Guam Housing and Urban Renewal Authority, the Bill authorizes the governor to effect the transfer. Senator Larry Kasperbauer, the Bill's author indicated that, although the Council has title to the property, the Council is still a government of Guam entity. Accordingly, any property it owns is subject to the provision of law that only the governor can transfer government real property.

III. FINDINGS AND RECOMMENDATION

The Committee on General and Omnibus Matters finds that the intent of Bill No. 10 to provide recreational facilities and bus shelters in the Machanao area is well founded. The residents of this densely populated area are seriously underserved in these basic necessities and have been for much too long, owing to the unavailability of land for these purposes. The willingness of the Archdiocese of

Agana to exchange property it owns in the area with nearby government-owned land presents an opportunity to rectify this long-standing problem.

Taking into account the testimony, questions and comments offered during the public hearing on the Bill, the Committee further finds that a provision for the surveying of the government land to be exchanged should be included and has amended it accordingly. A technical correction regarding the lot number for the property also has been made.

Accordingly, the Committee on General and Omnibus Matters to which Bill No. 10 (LS) was referred does hereby submit its findings and recommendations to I Mina' Bente Ocho Na Liheslaturan Guåhan **TO DO PASS BILL NO. 10 (LS),** "An act to authorize the Governor of Guam to exchange government land in Dededo for the purpose of developing recreational facilities."
