AN ACT TO APPROPRIATE FIVE HUNDRED THOUSAND DOLLARS (\$500,000) FROM THE REVENUE FUND OF THE 1997 INFRASTRUCTURE IMPROVEMENT BOND TO THE DEPARTMENT OF PUBLIC WORKS FOR THE DESIGN AND CONSTRUCTION OF THE "SAGAN BISITA" LOCATED IN AGAT.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Appropriation. Five Hundred Thousand Dollars (\$500,000) is hereby appropriated from the Revenue Fund of the 1997 Infrastructure Improvement Bond to the Department of Public Works for the design and construction of the "Sagan Bisita" located in Agat.
