

AN ACT TO APPROPRIATE TWO HUNDRED FIFTY THOUSAND DOLLARS (\$250,000) FROM THE REVENUE FUND OF THE 1997 INFRASTRUCTURE IMPROVEMENT BOND TO THE GUAM VISITORS BUREAU FOR THE PURPOSE OF MAKING IMPROVEMENTS TO THE GUAM SCENIC ROUTE.

BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. Legislative Statement. From 1989 to the present, the Principal
- 3 and Interest Accounts of the 1997 Infrastructure Improvement Bond have
- 4 accumulated sums in excess of those needed for payments to principal and interest.
- 5 These sums should have been, but have not been, transferred to the Revenue Account

- as mandated by the terms of the bond indenture. *I Liheslaturan Guåhan* intends to direct the Department of Administration to instruct the Trustee to make the transfer and to decide how best to utilize these funds.
- Section 2. Appropriation. Two Hundred Fifty Thousand Dollars (\$250,000) is appropriated from the Revenue Fund of the 1997 Infrastructure Improvement Bond to the Guam Visitors Bureau for the purpose of upgrading the existing Guam Scenic Route signs and for erecting new signs at scenic, historic and recreational areas.
